I, Rabindranath Das S/O- Murari Mohan Das do hereby lodge FIR against Gita Gope W/O- Golak Gope, Golak Gope S/O- Ananda Gope and Joydeb Kayal S/O- Manpuran Kayal for physical assaulting Raushan Kumar S/O- Late Uma Shankar Lal, JE-Gr. II attached to Joypur CCC, WBSEDCL.

On dated 10/10/2023 at about 6.30 pm a group of lawless people led by Gita Gope W/O- Golak Gope, Golak Gope S/O- Ananda Gope and Joydeb Kayal S/O- Manpuran Kayal entered into the premises of Joypur CCC, WBSEDCL at Garh Joypur, Purulia.

The persons named above are demanding reconnection of disconnected service connections stands recorded in the name of Ananda Gope, Consumer ID 242121244 of vill- Dhabani, PO- Hargara, PS- Joypur, Purulia and disconnected service connection of Sahadeb Kayal, Consumer ID 201864565 of Vill & PO- Joypur (Namopara), Purulia without making any payment to WBSEDCL. The undersigned expressed his inability to fulfill the demand i.e. reconnection of disconnected consumers without taking any payment.

On hearing such version Golak Gope S/O- Ananda Gope and Joydeb Kayal S/O- Manpuran Kayal became furious and started using filthy languages, they also threatened the undersigned to implicate in a false case of sexual harassment in presence of Raghunath Dutta, AM(F&A), Purulia Division, WBSEDCL, Durga Charan Mahato, Junior Manager (HR), Purulia Division, WBSEDCL and other officials of Joypur CCC, WBSEDCL. After some deliberation they physically assaulted Raushan Kumar S/O- Late Uma Shankar Lal, JE-Gr. II attached to Joypur CCC, WBSEDCL on which he got injury in his chest and head. After that the incident was also brought into the notice of Joypur PS over phone and one officer namely Mr. Mahadeb Rana, SI of Joypur PS came to our office and rescued us. After that Raushan Kumar S/O- Late Uma Shankar Lal, JE-Gr. II attached to Joypur CCC, WBSEDCL was taken to Joypur BPHC for primary medical examination at about 8.00 pm and the on duty medical officer advised him for CT Scan. Copy of emergency Prescription is attached for your ready reference.

Hence you are requested to take cognizance of offences and take suitable action as deemed fit against Gita Gope W/O- Golak Gope, Golak Gope S/O- Ananda Gope and Joydeb Kayal S/O- Manpuran Kayal and other accompany persons for physical assaulting a public servant while on duty under the Section IPC – 325, 332, 341,353 & 504.

Treat this memo as an FIR.
