Purulia to committed theft of electricity U/S 138 1(a) of electricity act 2003 subsequently amendment act 2007.

On 16.10.2023 at about 02.30 P.M I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01.Raushan Kumar, JE(E) Gr-II, Joypur CCC, 02. Shibaram Mahato, Gr-I TSH, Joypur CCC entered the premises of Sunil Mahato S/O- Late Niranjan Mahato of Forest More, PO- Tanasi, P.S- Joypur, Dist- Purulia and found that at present Sunil Mahato is died and Milan Pramanik S/O- Haren Pramanik was enjoying electricity unauthorizedly connecting with the service connection of Phanibhusan Mahato S/O- Late Niranjan Mahato (Meter No. BB0780500) of Forest More, PO- Tanasi, PS- Joypur Dist. Purulia at the disconnected premises of Late Sunil Mahato S/O- Late Niranjan Mahato of Forest More, PO- Tanasi, P.S- Joypur, Dist- Purulia. The connection of Late Sunil Mahato with meter No. P1358064 was disconnected on 01.07.2013 due to non-payment of energy bill. During inspection it is found that Milan Pramanik S/O- Haren Pramanik (Present user) enjoying power from another connection unauthorisedly and the connection of said premises is lying disconnected. Contractual load of connection of Late Sunil Mahato with meter No. P1358064 (Consumer ID: 242195211) is 0.59 kVA. The unauthorized connection is disconnected with final meter reading 00340. The inspection team left the premises at 02.55 P.M.

Milan Pramanik S/O- Haren Pramanik (Present user) of Vill- Tatuara, P.S- Kotshila, Dist- Purulia at the premises at Forest More, PO- Tanasi, PS- Joypur Dist.
