In producing herewith, the arrested accused person Akhbar Ansary (56 yrs) S/o-Late Jikir Ansary of Vill-Uporjari PS-Arsha Dist-Purulia along with seized articles viz (i) 06 pieces "L" type Iron angle length approx 32 Inch (ii) 05 pieces Iron hollow pipe length approx 36 Inch (3) 04 pieces Iron angle length approx 21 Inch (4) 04 pieces Iron angle length approx 23.5 Inch (5) One white colour polithin sheet (6) one black colour Motor Cycle (TVS 100 XL) bearing regd. No-JH01EV-0595 under proper seizure list.

I, ASI Nisith Das of Joypur PS do hereby lodge a written complaint against the aforesaid accused person, to the effect that on 16/10/2023 myself along with C/-681 Lotan Ch Dey, NVF/-803 Ankur Ch Mahato are perform special mobile duty at PS area vide Joypur PS CC No-2686/23 Dated-16/10/2023. As per order of IC Joypur PS when we were performed Naka Checking duty at Dumurdih Rail Gate under Joypur PS Dist-Purulia and at 18:25 hrs I, found that one black colour Motor Cycle (TVS 100 XL) bearing Regd. No-JH01EV-0595 was coming from Joypur Forest more side towards Kotshila side. On seeing the Naka Checking party he tried to fled away but somehow, we are manage to stop the Motor Cycle and found that the Motor Cycle was loaded with some Iron Materials with covered by one polithin chaat sack. On search it was found that (i) 06 pieces "L" type Iron angle length approx 32 Inch (ii) 05 pieces Iron hollow pipe length approx 36 Inch (3) 04 pieces Iron angle length approx 21 Inch (4) 04 pieces Iron angle length approx 23.5 Inch (5) One white colour polithin sheet. On demand he failed to produce any valid papers in respect of possession of the above noted articles. So, it is reasonable to believe that the above noted accused person collected the said above noted articles either by theft or by any fraudulent means from anywhere and transporting the same for selling to someone. As such, there is every reason to believe that the above noted articles illegally. So, I seized the same under proper seizure list in between 18:45 hrs to 19:15 hrs & duly signed by witnesses. During further interrogation he confessed his guilt. As such I arrested him and issued proper arrest memo is liable for prosecution U/S-379/411 IPC.

I therefore pray before you, kindly lodge an FIR against the accused person Akhbar Ansary (56 yrs) S/o-Late Jikir Ansary of Vill-Uporjari PS-Arsha Dist-Purulia as per law and arrange for its investigation.
