I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Narun Hudu Sadagar, S/O- Hussain Sadagar of Vill- Rangadih, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 17.10.2023 at about 10.40 A.M I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01.Raushan Kumar,JE(E) Gr-II,Joypur CCC , 02. Ganesh Mahato, Gr-I TSH, Joypur CCC entered the premises of Narun Hudu Sadagar, S/O- Hussain Sadagar of Vill- Rangadih, P.S- Joypur , Dist- Purulia and found that Narun Hudu Sadagar, S/O- Hussain Sadagar was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Narun Hudu Sadagar with meter No. HR045921 was disconnected on 09/12/2019 due to non payment of energy bill. During inspection it is found that Narun Hudu Sadagar reconnects his service connection with LTOH line unauthorisely and enjoying power in his premises. Contractual load of his connection (Consumer ID: 202489199) is 0.300 kVA. The connection is disconnected from LTOH line with final meter reading 006832. The inspection team left the premises at 11.05 A.M.

Narun Hudu Sadagar, S/O- Hussain Sadagar of Vill- Rangadih, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
