I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Bipad Bhanjan Singh, S/O- Late Basudev Singh (Present user) of Vill- Dahikuri, PO- Ghagra, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 17.10.2023 at about 11.25 A.M I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01.Raushan Kumar,JE(E) Gr-II,Joypur CCC , 02. Ganesh Mahato, Gr-I TSH, Joypur CCC entered the premises of Basudev Singh S/O- Late Budhan Singh of Vill- Dahikuri, PO- Ghagra, P.S- Joypur , Dist- Purulia and found that at present Basudev Singh is died and Bipad Bhanjan Singh, S/O- Late Basudev Singh was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Late Basudev Singh with meter No. B3954353 was disconnected on 13/12/2019 due to non payment of energy bill. During inspection it is found that Bipad Bhanjan Singh reconnects the service connection of Late Basudev Singh with LTOH line unauthorisely and enjoying power in his premises. Contractual load of the connection (Consumer ID: 200128180) is 0.24 kVA. The connection is disconnected from LTOH line with final meter reading 007707. The inspection team left the premises at 11.45 A.M.

Bipad Bhanjan Singh, S/O- Late Basudev Singh (Present user) of Vill- Dahikuri, PO- Ghagra, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
