In producing herewith, the arrested accused persons namely 1) Dil Mahammad Ansary @ Gera (23) S/o-Karim Ansary of vill- Nopara, PS-Puncha, Dist-Purulia driver of Tata Yodha Pick up having registration no- WB 39C- 0055 2) Tafik Sha (20) S/o- Iyakub Sha of vill- Nopara, PS-Puncha, Dist-Purulia Khalasi of Tata Yodha Pick up having registration no- WB 39C- 0055 along with seized articles (1) One Tata Yodha Pick up having registration no- WB 39C- 0055 (2) Total 50 pieces Galvanize iron made plate use for road safety guard, (01pcs length approx 06 feet, wide approx 5.5 inch, curve both side approx 2.4 inch) loaded on the Tata Yodha Pick up having registration no- WB 39C- 0055 under proper seizure list.

I, SI Nagendra Nath Das of Kenda PS do hereby lodge a written complaint against the aforesaid accused persons, to the effect that on 18/10/2023 myself along with C/870 Arup Karmakar and C/812 Tanmay Kundu were engaged in my special mobile duty at Kenda PS area perform special mobile duty at PS area vide Kenda PS CC No-1852/23 Dated-18/10/2023. As per order of OC Kenda PS when we were performed special mobile duty near Keshya More under Kenda PS Dist-Purulia and my reliable source information that one Tata Yodha Pick up loaded with Galvanize iron made plate use for road safety guard, (01pcs length approx 06 feet, wide approx 5.5 inch, curve both side approx 2.4 inch) coming from Barabazar side through Barabazar- Sindri-Kenda Pitch road . After gating information myself along with my accompanying forces rushed to the anticipated place and reached at near Keshya More at 18:45 hrs. on way I have tried to collect local witnesses from the nearby villages, but not to avail all my efforts ended in vain. On seeing the Police Party from a distance two persons tried to flee away from the spot leaving behind the Tata Yodha Pick up bearing no WB 39C- 0055 loaded with Galvanize iron made plate of road safety guard; however we the police party after a hot chased could intercept. On demand they failed to produce any valid papers in respect of possession of the above noted articles. So, it is reasonable to believe that the above noted accused persons collected the said above noted articles either by theft or by any fraudulent means from anywhere and transporting the same for selling to someone. As such, there is every reason to believe that the above noted articles illegally. So, I seized the same under proper seizure list in between 19:05 Hrs to 19:55 Hrs & duly signed by witnesses. During further interrogation they confessed their guilt. As such I arrested them and issued proper arrest memo is liable for prosecution U/S-379/411 IPC.

I therefore pray before you, kindly lodge an FIR against the accused persons 1) Dil Mahammad Ansary @ Gera (23) S/o-Karim Ansary of vill- Nopara, PS-Puncha, Dist-Purulia 2) Tafik Sha (20) S/o-Iyakub Sha of vill- Nopara, PS-Puncha, Dist-Purulia and others as per law and arrange for its investigation.
