The above-named complainant begs to state as follows :-

- 1. That the complainant is the legally married wife of the accused no.1 and their marriage was solemnized on 18.04.2018 corresponding to 4th Baisakh, 1425 B.S. according to the hindu rites and customs prevalent in their community.
- 2. That at the time of marriage the father of the complainant gave of Rs. 30,000/-, one bhori gold ornament, utensils and clothing as per demand of her in-laws house.
- 3. That the accused no.1 is the husband, accused no.2&3 are father-in-law and mother-in-law of the complainant respectively.

4. That after marriage the complainant went to her matrimonial home with her husband i.e. accused no. 1 and had been residing the with him as husband and wife.

5.That after one month of their marriage ,the accused persons demanded further Rs.20,000/- but the complainant expressed the inability of her father to fulfill such unjustified demand. As a result the accused persons started inhuman physical and mental torture upon the complainant. The accused no.1 used to come at late night in drunken condition and used to assault the complainant without any reason whatsoever. The complainant reported the matter to her parents and they on several times requested them to keep their daughter peacefully. In this way the complainant had been spending in her matrimonial home with very difficulties and bore all such things with a hope that on passage of time if the behaviour of the accused persons are changed in coming future.

6. That in the mean time the complainant gave birth two sons and one daughter but the accused no.1 did not provide a single rupee for her medical expenses. The father of the complainant bore all such expenses. Thereafter when the complainant became place deteriorated since then the accused persons did not use to like her. Often the accused no.1. used to say that he will marry for the second time.

7.That due to unbearable torture, the complainant in the 1st week of pous ,2022,came to her father's house with her children. Thereafter in the middle of magh,2023 the accused no.1 came to the house of the complainant's father and forcibly took away his eldest son and daughter to his house. The complainant informed the matter to Mahila Thana, Dhanbad and with their intervention the complainant got her children back and as per their direction the accused no.1 brought the complainant and her children to his house.

8.That thereafter again in the last week of Ashar,2023 the complainant was physically tortured by the accused persons and finding no other alternative the complainant with her minor children took shelter in her father's house at village Poradih.

9.That on 06.08.2023 corresponding to 20th Shraban, 1430 B.S. in the evening the accused no.1 i.e, the husband of the complainant came to her father's house at village poradih and at night he assaulted the complainant mercilessly and told her that he has married for the second time and also threatened her by saying that you would not go to in-laws house otherwise he will kill her. Thereafter in the early morning without informing to any one, the accused no.1 flee away.

10. That thereafter on 07.08.2023 the complainant lodged a written complaint against the accused persons before the O.C., Kotshila P.S. by post but the police did not take any step against the accused persons, then the complainant lodged a written complaint before the Superintendant of Police, Purulia on 14.08.2023 but till now no action has been taken against the accused persons.



It is ,therefore, prayed that your Honour would be graciously pleased to send this petition of complaint to the O/C, Kotshila P.S. as contemplated under section 156(3) of the Cr.P.C.for investigation after treating it as F.I.R. for the interest of justice.
