Entered the premises of PRATHAM HANSADA S/o LT. KALICHARAN HANSADA, resident at POGRO, PS- KOTSHILA, Dist- PURULIA having consumer Id- 200183477, Meter no T1673936 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. by tapping the incoming service cable i.e. U/S 135(I)(b) was detected. The details of bypassing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 02 nos.
2. Electric FAN- 01.

Out of which I seized the following.


1. Two core service cables approx length 04 ft along with bypassing arrangement.


