Sub: - To lodge FIR against driver/owner of three wheeler engine fitted trolley van namely Bablu Bauri (37) S/O Amullya Bauri of village- Polasbani, PS- Manbazar, Dist- Purulia.

Sir,

In producing herewith accused driver/owner namely Bablu Bauri (37) S/O Amullya Bauri of village- Polasbani , PS- Manbazar, Dist- Purulia along with three wheeler engine fitted trolley van loaded with 30 (Thirty) Sacks of sand containing approx (30 cft) myself S.I. Banshidhar Mukherjee along with C/786- Suchand Mandi and NVF/697- Debendranath Bauri Vide Manbazar P.S C.C No 2035/23 and GDE No- 511 dt- 12.10.2023 was engaged for night mobile duty. In course of my duty on 13.10.2023 at 07:55 hrs. received a telephonic information from table duty officer ASI Anirban Banerjee of Manbazar PS that illegal sand lifting is going on in Kangshabati river bed at Harekrishnapur Mouza under Manbazar PS, Dist- Purulia. Subsequently myself along with force moved to the spot. We kept our vehicle concealed and keep watch to the Harekrishnapur river bed. After spending sometime at that anticipated place found one three wheeler trolley van has been loaded with 30 (Thirty) sacks containing approx 30 cft. sand by the driver/owner of the trolley van. We rushed there and detained the said vehicle, being asked the driver/owner of the said vehicle disclosed himself as Bablu Bauri (37) S/O Amullya Bauri of village- Polasbani , PS- Manbazar, Dist- Purulia but he failed to give satisfactory answer for lifting the sand from Harekrishnapur Mouza, Kangshabati river bed. So there is every reason to believe that the driver/owner of the above-mentioned vehicle with ill motive is transporting & lifting sand illegally without any valid document in support of carrying / lifting sand.

Hence I seized the above noted Three wheeler engine fitted trolley van loaded with 30 (Thirty) Sacks containing approx (30 cft) sand and arrested the driver/owner namely Bablu Bauri (37) S/O Amullya Bauri of village- Polasbani , PS- Manbazar, Dist- Purulia

Therefore, I pray before you that a case may kindly be started against the driver/owner of the above-mentioned vehicle and oblige.
