Than the above named accused person's and three unknown persons most illegally armed with deadly weapons lie Lathi, iron rod etc. entered into her house, and

started abusing the complainant . the complainant protested of their illegal act but they did not pay and heed to the request of the complainant. Then they assaulted the complainant by fist and blow and took away a sum of Rupees Five Thousand only, one golden neckless and Deed and chain deeds of the properties from a Box and the Kolshi (brass). The complainant makes a noise by saying Bancho Bancho. Hearing the noise, the witnesses came and now the incident then the Accused person's left the place with dire consequences.

- 3) That on the following date the complainant went to Manbazar Police Station and reported the matter to Police personnel of Manbazar P.S. After few days, the complainant inquired about her complainant and came to learn no case has been registered against the Accused persons. Then the complainant informed the matter to S.P. Purulia. But off no good. Now for getting appropriate relief the complainant file this case for proper legal action against the Accused person's and this is the caused for delay.
- 4) That the Accused persons have committed a Criminal Offences and they are liable to be punished accordingly.

It is therefore prayed be before your Honour would be pleased to direct the officer-in-charge Manbazar P.S. for investigation of the case against the Accused by treating this complaint as F.I.R. provided U/s-156(3) Cr.P.C.
