Sir,


I SI Prabir Kr Dey posted at Manbazar PS do here by lodge a suo moto complaint against 05/06 unknown villagers of Baidyanathpur village to the effect that, on 27/28.10.2023 I was engaged for night mobile duty with C/1544 Prasenjit Bhattacharjee and HG/1443 Uttam Kumar Sing along with Govt. vehicle No.WB24K/7673 all are Manbazar PS vide Manbazar PS CC No.2193/23 and GDE No. 877 date 27.10.2023. During said duty myself along with force reached at Duarsini village and at about 01:00 hrs. received Mobile call from O/C Manbazar PS that one person has been restrained suspected as thief by Baidyanathpur villagers at said village and as per direction of O/C Manbazar PS myself along with force went to Baidyanathpur village.


We reached near Baidyanathpur Primary School at Baidyanathpur village and found the villagers assembled in front of one person suspected as thief. Also found that the person have been manhandle by local villagers who received bleeding injuries on his person. As per statement of villagers it is learnt that, 05/06 persons with him has fled away. Somehow the villagers managed to catch him. I rescued him from the said place and after that on interrogation him it comes to light that the name of the person is Jiten Mudi (25 Years) male S/O-Dipak Mudi of Vill-Sarbagan, PS-Purulia (T), Dist-Purulia. He went to his relative's house but he could not fix the road then he entered in to the said village where the villagers restrained him and after some conversation 05/06 unknown villagers became furious and beaten him by lathi suspecting as thief. As a result he received injuries on his person.

Thereafter I brought him to Manbazar Rural Hospital where on duty M.O. checked him and admitted at said Hospital on 28.10.2023. Presently he is under treatment.

So I would like to request you to start a specific case under proper section of law against all the involved accused persons who restrained said Jiten Mudi and beaten him and arrange for its investigation.
