Sir,

In producing herewith arrested person namely Jiten Mudi (25 Years) male S/O-Dipak Mudi of Vill-Sarbagan, PS-Purulia (T), Dist-Purulia along with seized articles viz.


(1) Two pcs. of Arrow approx two feet long with Bamboo stick in which Iron Fala on top. (2) One piece bamboo made Bow. I SI Sanjib Kr Sen posted at Manbazar PS, District Purulia do here by lodge a suo moto complaint against Jiten Mudi (25 Years) male S/O-Dipak Mudi of Vill-Sarbagan, PS-Purulia (T), Dist-Purulia and 06/07 others to the effect that, today on 28.10.2023 I was endorsed by OC Manbazar PS to investigate Manbazar PS case No.86/23 dtd 28.10.23 U/S 341/323/325/34 IPC. Accordingly myself along with C/855 Tarun Mahato and HG/1419 Santanu Dutta left for Baidyanathpur village vide Manbazar PS G.D.E No. 887, CC No. 2197/23 dated 28.10.2023 and investigated the case in presence of villagers. During Investigation I came to know from villagers that, on 27/28.10.23 night 06/07 unknown persons Armed with deadly weapons reached in the village Baidyanathpur under Manbazar PS and assembled there and tried to commit Dacoity in the house of Bharat Kishore Mahato S/O Lt Sudhir Kumar Mahato of village Baidyanathpur, PS Manbazar, District Purulia. At that time the neighbours of the house of Bharat Kishore Mahato wake up for nature's call and found them and shouted and chased them. At that time villagers also chased them and was able to catch the above noted persons who was manhandled by villagers and was sent to Manbazar Rural Hospital with the help of Police while others fled away. After that, villagers showed the way through which the accused persons fled away and also the place from where I searched and seized the above noted articles as Alamat of this case.

After that we reached at Manbazar Rural Hospital and contacted with on duty M.O. as well as injured Jiten Mudi and interrogated him. During interrogation Jiten Mudi stated that, on that night he along with 06/07 other persons went to Baidyanathpur village to commit Dacoity but could no trace out the house of Bharat Kishore Mahato. In this the local villagers chased them and caught him while others fled away. After that the villagers has beaten him and brought him at Manbazar Hospital with the help of Police.

After brought him to Manbazar Rural Hospital, on duty M.O. checked him and admitted at said Hospital on 28.10.2023. So I arrested him as he along with 06/07 other persons assemble there and was preparing to commit dacoity at Baidyanathpur village

So I would like to request you to start a specific case under proper section of law against Jiten Mudi and six others for assembling to commit Dacoity and arrange for its investigation.
