Today (19.10.2023) at about 12:00 hrs acting upon secret source information I S.I. Bapan Mondal officer – in – charge Manbazar PS along with SI Banshidhar Mukherjee, ASI Sambal Kr. Singh and force vide Manbazar PS GDE No- 603 dtd- 19.10.2023 proceeded towards Manbazar upparpara for holding raid against illegal stock and selling of banned fire crackers in the shop-cum residence of Paban Kumar Bagri S/O Brijmohan Bagri of Manbazar Upparpara, PS- Manbazar, Dist- Purulia. According to my source information I along with force identified the shop Mahalaxmi Telecom on 19-10-2023 at 12:10hrs. and being asked the shop keeper disclosed his name as Paban Kumar Bagri (38) S/O Brijmohan Bagri. Thereafter, I with the help of accompany force conducted searching in his shop cum residence and found a huge quantity of banned fire crackers in his shop cum residence. On being asked the said Paban Kumar Bagri failed to produce any valid documents for possessing and keeping the same in his shop cum-residence. So, I seized the following banned fire crackers by preparing proper seizure list and labeled all the seized articles in presence of Police witnesses as no public witnesses were agree to stand as witness in this case.

The seized fire crackers are as follows:- 1) Rolex Chocolate Bomb 55 packets containing 10 pcs in each packet, 2) Black cat chocolate Bomb 25 packets containing 10 pcs in each packet, 3) Non leveling chocolate Bomb 03 packets containing 12 pcs in each packet, 4)Loose Chocolate Bomb 108 pcs, 5) Alu Bomb 06 packets containing 100 pcs in each packet, 6) Blue Bijli crackers 130 packet containing 100 pcs in each packet, 7) Yellow Bijli Turky crackers 50 packet containing 100 pcs in each packet, 8) Bijli Turky crackers Pink colour 100 packet containing 100 pcs in each packet, 9) Samis Rhino power original Chocolate Bomb 1 packet containing 10 pcs, 10) Tumpa 3 in 1 silver tree 05 packets 10 pcs in each packet, 11) Medium silver tree 13 packets containing 5 pcs in each packet, 12) Tumpa Chutput Fire crackers 35 packets containing 10 pcs in each packet, 13) Payel chutput Fire crackers 11 packets containing 10 pcs in each packet, 14) Tohta No-1 Chocolate Bomb 1 packet containing 12 pcs, 15) Flower Bomb 1 packet containing 10 pcs, 16) Two sound lose 9 pcs, 17) Keerthika's chain fatka 1 bundle, 18) Sri Vijai Bijli fire crackers 13 packets containing 100 pcs in each packet.

I observed that, above articles have been stocked by him. Being asked he stated that, he has stocked those articles for selling to public. He failed to produce any document for stocking such combustible and explosive substances.

So, there is every reason to believe that, knowingly he has conducted negligent act in respect of such explosive and combustible substances which are endanger to human life and to cause injury to human life. He has also violated the order of the Hon'ble Apex Court and order of West Bengal Pollution Control Board which promulgated by these authority. He also did not co-operated with me for proper enquiry of the matter.

So, I seized all the above articles and arrested him after preparing arrest memo and brought him to PS. Therefore I lodge a complaint and started Manbazar PS Case No- 84/23 dtd- 19.10.2023 U/S – 188/285/286 IPC r/w 24/26 WBFS Act. 1950.
