Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Parikshit Mondal (61 Yrs) S/O- Lt. Dwijapada Mondal of Vill-Gopalpur, PS-Neturia, Dist-Purulia with seizure of 17 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (09.10.2023) while I, ASI Mukesh Bauri, along with force were performing special mobile duty vide Neturia PS GDE No-363 Dt. 09.10.2023 and acting on source information after consulting you at about 17:55 hrs reached at village Gopalpur and held raid in the hotel styled as "Mondal Hotel" of Parikshit Mondal (61 Yrs) S/O- Lt. Dwijapada Mondal of Vill-Gopalpur, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 17 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Parikshit Mondal (61 Yrs) S/O- Lt. Dwijapada Mondal of Vill-Gopalpur, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1302 Radhagobinda Dhibar (2) C/1361 Munshi Kamal Hassan and (3) C/159 Dinesh Sardar all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Parikshit Mondal (61 Yrs) S/O- Lt. Dwijapada Mondal of Vill-Gopalpur, PS-Neturia, Dist-Purulia under proper section of law.
