

Respected Sir,

This is to bring in your kind attention that on 7th October 2023 around 9:45 am unwanted incident happened inside the plant premises where many union employees obstructed the main gate and stopped HR & ADMIN team to enter inside the plant premises. And, they later came to HR office and demanded to increase wages. But, when the management tried to make them understand and asked for discussion which they refused and they used profanity languages later they physically assaulted few employees such as Plant General Manager, HR Head, etc. Attached copies of their complaints are enclosed too!!! They also tried to damage company assets even switched off the CCTV as well.

Also, the security persons (ASO) - Mr. Somnath Mondal and Shantanu Das tried to stop the mob entering the HR premises but the culprits assaulted them for which we had to send them to hospital for better treatment. Attached are the medical reports of them.

I would also love to draw your kind attention that this is not the first time. This is a repeated offence which we overlooked several times. So, I had let go this kind of situation in the past. But, this time I am bound to inform you.
