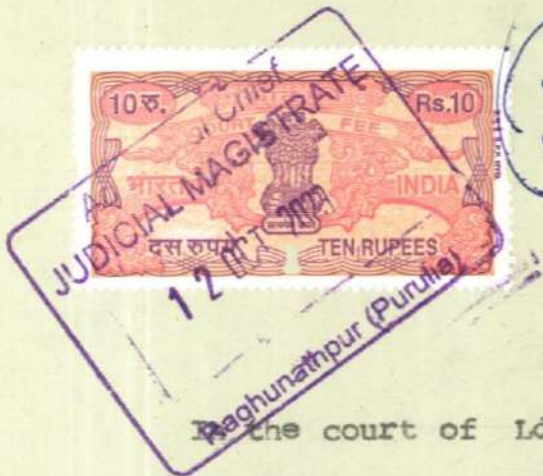

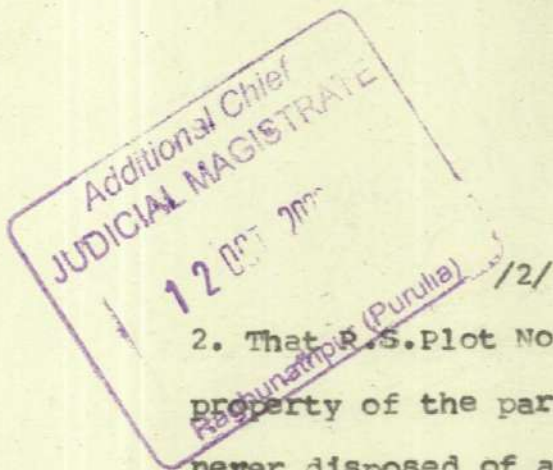

2. That P.S. Plot No. 32 of mouza Ranpur, is the paternal common property of the parties and complainant submits that he has never disposed of any portion of his legitimate share within said plot to any body else.

3. That facts remain on 14.08.2023 morning complainant had been to his paternal house from his present residence at Asansol and had some conversation with the Accd person regarding landed property but surprisingly said conversation ~~but~~ Accd. person became furious while an issue regarding aforesaid plot came in between complainant and accd. person in which accd first time disclosed that he has a regd gift in respect of ownership of said plot duly executed by the complainant long ago before A.D.S.R. office, Raghunathpur. Needless to say such utterance of Accd. came for the complt as ~~both~~ from the Blue since he has never executed such alleged Regd. in favour of the accd person at any point of time. Accd person also gave out threat to disposses the complaint even in exchange of life of the complt.

4. That owing to such desperate and illegal activities of of the Accd. person complt became spell bound and collected the certified copy of alleged deed from the concernng ADSR office after prolong search and on 17/08/2023 he obtained the certified copy of alleged Deed No. 2052/2008 in ~~xxxx~~ which he never put his signature or affixed photo or finger print before the office concern on thex alleged deed hence the same is fake, ingenuine collusive and accd person by practising fraud had managed to get it registered with a view to deprive the complainant. Be it mentioned complainant got the alleged signature in the deed No. 2052/2008 verified in comparision with his signature putting them before,

managed to get the ~~certified~~ gift deed No. 2052/2008 fraudulant-

ly behind the back of knowledge of the complainant by putting a

fake signature in the name of complainant with a view cheat and

deprive the complainant from his legitimate property. Accd. has

done every thing in sound body mind and intentionally.

5. That the original copy of the alleged deed being No.2052/2008 is under the custody of Accd. person.

6. That from the on going paras it is abundantly clear that accd. person has committed the offences as attributable under sections mentioned above.

7. That the complainant against such offence reported the matter to the O/C, Neturia P.S. for taking action but unfortunately it became fruitless, thereafter complt. sent his grievances to the S.P. Purulia through Regd. post on 3/10/2023 but till date no action has yet been taken to that effect. Hence finding no other alternative complt seeks his remedy before Id. court.

It is therefore prayed that necessary direction upon O/C, Neturia may kindly be passed to cause investigation into this case treating this petition as an F.I.R.U/S.156(3) Cr.P.C. And
