Sir.

In producing herewith one seized Tractor having registration No. WB 81/3031, Chassis No-MBNTFAEDBNRC00808, Engine No-RNC7EBN0869 (Make- Mahindra B275 DI SP PLUS) along with trolley loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, SI Jyotilal Mahato along with C/1302 Radhagobinda Dhibar and C/1361 Munsi Kamal Hassan were performing anticrime day mobile duty vide Neturia PS GD No- 906 Dt. 22.10.23 & CC No- 3596/23 Dt. 22.10.23 at PS area and today on 22.10.2023 at about 12:05 hrs while performing mobile duty at Inanpur More, received a credible source information that one tractor loaded with illegal sand in trolley coming from Jhanka side towards Sarbari side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Jhanka More side and at about 12:25 hrs reached at Nimdanga village More and found that above noted tractor was coming from Jhanka More side and suddenly the driver stopped the tractor there and after seeing the police party, he got down from the tractor and started to run towards the village area. We chased to apprehend the driver but in spite of hot chase he managed to flee away. Then we searched the tractor and found that the vehicle (tractor) having registration No. WB 81/3031, Chassis No-MBNTFAEDBNRC00808, Engine No-RNC7EBN0869 (Make-Mahindra B275 DI SP PLUS) loaded with sand in Trolley approx 100 Cft. I along with force waited there for some time but no one turn up at that moment & none produce any valid documents in respect of that sand.

So, there is reason to believe that the driver and registered owner of the tractor have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen.

Accordingly, I seized the tractor having registration No. WB 81/3031 along with trolley loaded with sand approx 100 C.Ft. at 13:35 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the tractor have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of tractor having registration No. WB 81/3031 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange for its investigation.
