Sir,

In producing herewith the arrested one accused person namely Makbul Ansary (50 Yrs) S/o Lt. Babujan Ansary of Vill- Aguitard, PS- Santaldih, Dist- Purulia with seized articles as per seizure list.

I, ASI Dipankar Mahanti of Para PS beg to report that on 08.10.2023 myself along with force viz, C/1474 Tushar Kanti Mandal, C/997 Rajkumar Bauri and C/638 Lalchand Bag were performing Night patrolling duty at Dubra side area vide Para PS GDE No- 334 and CC No- 3448/23 dated 08.10.2023 with Govt. vehicle. On 09.10.2023 at 00.15 hrs received a credible source information that 7/8 persons being armed with deadly weapons assembled in an open place near Ketlapur Railway gate under Para PS with a view to commit dacoity. The information was communicated to O/C Para P.S and as per his direction in order to work out the information myself along with force who were with me left for the place where they were assembled. We reached near the spot, approx ½ km away from the actual place, around 00.35 hrs. Keeping the vehicle in a safe distance, we started on foot and slowly arrived near the spot and heard some whispering of some persons. We the Police party without wasting a single moment tried to encircle them from behind. With the help of the focus of the torch light we noticed that 7/8 persons being armed with deadly weapons like dagger, iron rod, lathi were assembled in an open place near Ketlapur Railway gate. Seeing the Police party all of them started to escape but after a hot chase the above noted accd. person could be apprehended.

On primary interrogation the apprehended accused person stated his name and address as noted above and confessed that he was assembled there for committing dacoity in Dubra village. Before entering into the search of his person, tried to find out some local independent witnesses but as the place is an isolated one none could be available.

During search found one dagger measuring approx 08 inch from the exclusive possession of accd. Makbul Ansary (50 Yrs) S/o Lt. Babujan Ansary of Vill- Aguitard, PS- Santaldih, Dist- Purulia. Thereafter also search the P.O. from where the following articles were also seized i) One blue & white colour Honda Shine SP Motor Cycle without number plate with tempering Engine number & Chassis number, ii) One black colour SP Honda 125 Motor Cycle bearing Regd. No- WB82F/2452, iii) One iron made "BHOJALI" measuring 12 inch approx, iv) One iron made Shabal measuring approx 18 inch, v) One iron made Shabal measuring approx 25 inch, vi) One burning candle, vii) 32 Pcs playing cards, viii) one plastic sheet, ix) One green colour nylon rope measuring approx 25 feet was recovered and x) one plastic Torch light. So there is sufficient reasonable ground to believe that they were assembled there at that odd hours with deadly weapons with a view to commit dacoity. So, I arrested him, informing him of the ground of his arrest and seized the above articles under proper seizure list duly signed by witnesses and accd person observing all formalities and procedures of law. The seizure was made between 01.15. hrs to 01.55 hrs. on 09.10.2023.

Therefore I pray that a specific case may kindly be started against the above noted accd. persons and arrange for its investigation.
