Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Amar Duary (34 yrs) S/O- Lt. Niranjn Duary of Vill- Poradih PS-Puncha,Dist-Purulia with seizure of 32(Thirty Two) Sealed plastic bottles Country spirit style as "Dil Khush"containing 375 ml. each which were seized and labeled under proper seizure list.

I beg to submit that today (11.10.23) at 22:15 hrs while I SI Sunil Kr. Mudi along with C/1379 Bankeswer Duley and HG/1846 Panchanan Mahato both of Puncha PS were performing Spl Mobile Duty vide Puncha PS GDE No-469/23 Dated 11.10.2023 and acting on source information after consulting you at about 20:25 hrs reached at Tusugoria more and held raid in the hotel of Amar Duary (34 yrs) S/O Lt. Niranjn Duary of Vill -Poradhi PS- Puncha District- Purulia and found that the above noted person was keeping/selling liquor which were kept in his hotel at Tusugoria More on demand Amar Duary failed to produce any valid document/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents as such he committed offence / 46 A(c)BE Act 1909 so he was arrested in 11.10.23 at 20.45 hrs. U/S 67 BE Act and also 32 (Thirty Two) Sealed plastic bottles Country spirit style as "Dil Khush" containing 375 ml. each which were seized under proper seizure list duly signed by arrested accused & witnesses and labeled out of which 01 (One) bottle Dil Khush collected as a sample at the time of seizure During arrest I followed all the guide lines of Ld Apex Court. NHRC & WBHRC and the ground of arrest was duly notified and informed has relative issued arrest memo and handed a copy of the same to arrestee.

The arrested accd person namely Amar Duary (34 yrs) s/o Lt. Niranjn Duary of Vill - Paradih PS -Puncha. Dist- Purulia has committed offense U/S 46A(c) BE Act. 1909 for unauthorized possession and sale of liquor

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Amar Duary (34 yrs) s/o Lt. Niranjn Duary of Vill -Paradih PS -Puncha. Dist- Purulia under proper section of law
