Respected Sir,

In producing herewith one accd. person namely Nirmal Gorain (39 yrs) S/O-. Mahadeb Gorain of Vill- Madhya Puncha, PS-Puncha,Dist-Purulia with seizure of 36(Thirty Six) Sealed plastic bottles Country spirit style as "Dil Se"containing 375 ml. each which were seized and labeled under proper seizure list.

I beg to submit that today (15.10.23) at 21:05 hrs while I SI Abhijit Das along with C/1548-Subrata Paramanik and HG/1443 Hemmanta Baskey both of Puncha PS were performing Spl Mobile Duty vide Puncha PS GDE No-1060/23 Dated 15.10.2023 and acting on source information after consulting you at about 19:15 hrs reached at Madhya Puncha and held raid in the tea stall of Nirmal Gorain (39 yrs) S/O-. Mahadeb Gorain of Vill- Madhya Puncha, PS-Puncha,Dist-Purulia and found that the above noted person was keeping/selling liquor which were kept in his tea stall at Madhya Puncha on demand Nirmal Gorain failed to produce any valid document/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents as such he committed offence / 46 A(c)BE Act 1909 so he was arrested in 15.10.23 at 19.45 hrs. U/S 67 BE Act and also 36 (Thirty Six) Sealed plastic bottles Country spirit style as "Dil Se" containing 375 ml. each which were seized under proper seizure list duly signed by arrested accused & witnesses and labeled out of which 01 (One) bottle Dil Se collected as a sample at the time of seizure During arrest I followed all the guide lines of Ld Apex Court. NHRC & WBHRC and the ground of arrest was duly notified and informed has relative issued arrest memo and handed a copy of the same to arrestee.

The arrested accd person namely Nirmal Gorain (39 yrs) S/O-. Mahadeb Gorain of Vill-Madhya Puncha, PS-Puncha,Dist-Purulia has committed offense U/S 46A(c) BE Act. 1909 for unauthorized possession and sale of liquor

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Nirmal Gorain (39 yrs) S/O-. Mahadeb Gorain of Vill- Madhya Puncha, PS-Puncha, Dist-Purulia under proper section of law


