Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested alleged driver namely Hossain Alam (55 Yrs) S/o- Bande Nawaz of 21/58, S.K.D Colony, PS- Adoni, Dist- Kurnool, Andhra Pradesh and seized Truck having registration No- AP 07TH 7717 loaded with approx 22 (Twenty Two) Ton coal and also taken sample of 02 kg coal from the Truck.

I beg to state that on 07.10.2023 at about 19.35 hrs while I, ASI Biswajit Kalindi along with C/- 692- Mohil Ch. Mahato, C/- 154 Rajib Nag both of Purulia (M) PS, Dist- Purulia vide Purulia (M) C.C No- 3928/2023, Dtd: 07.10.2023 and GDE No- 331 Dtd. 07.10.2023 were performing mobile duty at PS area I received information from my source that one Truck having registration No- AP 07TH 7717 loaded with illegal coal is going towards Chhara X-jug on Aimundih-Chhara by pass road. After receiving the information I contacted you and as per guidance and instruction we left that place to track and stopped this illegal transportation of coal. After a long chase I managed to stop the vehicle near Nadiara village morh under Purulia (M) PS at about 19.20. On seeing the Police party the driver of the vehicle tried to flee away but we managed to apprehend him. On being asked the apprehended person disclosed his identity noted above. On demand he failed to produce any valid document in respect of loaded coal. On preliminary enquiry it could be learnt that the driver along with the owner of the said vehicle were procuring the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. So, it is reasonable to believe that they were transporting the coal illegally after procuring.

Accordingly I seized the above noted vehicles loaded with coal approx 22 TON under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list during seizure. I have taken 02 Kg coal from the truck as sample after preparing proper level. The seizure was made between 19.35 to 20.05 hrs. I also arrested the above noted accused person at 20.15 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. After that we made a proper arrangement and brought the arrested accused and seized vehicle loaded with coal at PS for custody.

Therefore, I pray before you that a specific case may kindly be registered against the driver namely Hossain Alam (55 Yrs) S/o- Bande Nawaz of 21/58, S.K.D Colony, PS- Adoni, Dist- Kurnool, Andhra Pradesh and the owner of the seized vehicle Truck having registration No- AP 07TH 7717 under proper section of law.
