Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Dilip Rajwar (55 Yrs) S/o- Lt. Ashari Rajwar of Vill- Kukurgoria, A/P Vill- Bhul Satar, PS- Purulia (M), Dist- Purulia and seized articles Approx 18 (Eighteen) liters illicit distilled liquor kept in a Jarkin along with seizure list, Memo of Arrest.

I beg to state that today (08.10.2023) evening while I along with force (i) C/- 699 Biswajit Banerjee (ii) C/- 24096 Binayak Dubey & (iii) HG- 1618 Haripada Gorai all of Purulia (M) PS vide GDE No- 382 Dtd. 08.10.2023 were performing mobile duty. During my mobile duty, at about 17.35 hrs I received a secret tip off that an illegal possession of a huge quantity of liquor. Subsequently, I informed the matter to you and as per your direction, I rushed to the house of Dilip Rajwar situated at Kukurgoria village under Purulia (M) PS and after arriving at the spot and as per your instruction conducted raid in the said house at about 18.15 hrs. During the raid some people fled away and detained one person. On being asked he disclosed his identity as Dilip Rajwar (55 Yrs) S/o- Lt. Ashari Rajwar of Vill- Kukurgoria, A/P Vill- Bhul Satar, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he stocks the illicit distilled liquors for selling illegally in his house. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said illicit liquors in his house. Subsequently, I seized Approx 18 (Eighteen) liters of illicit distilled liquor kept in a Jarkin in which 500 ml of liquor was taken as samples from the said Jarkin in a bottle. I seized the same under proper seizure list in presence of witnesses, duly signed by the witnesses and accused person. The seizure was made between 18.25 and 18.40 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Accordingly, I arrested the involved accused person namely Dilip Rajwar (55 Yrs) S/o- Lt. Ashari Rajwar of Vill- Kukurgoria, A/P Vill- Bhul Satar, PS- Purulia (M), Dist- Purulia at 18.55 hrs after maintaining all formalities regarding arrest and NHRC guidelines, issued Memo of Arrest. Informed him regarding the ground of arrest and also informed his family members.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Dilip Rajwar (55 Yrs) S/o- Lt. Ashari Rajwar of Vill- Kukurgoria, A/P Vill- Bhul Satar, PS- Purulia (M), Dist- Purulia under proper section of Law.
