Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused persons namely (i) Sikandar Bauri (28 Yrs) S/o- Mathur Bauri o Purulia Karpurbagan, PS- Purulia (T), Dist- Purulia & (ii) Prasenjit Banerjee (27 Yrs) S/o- Apu Banerjee of Vill- Bongabari near Shiva Mandir, PS- Purulia (M), Dist- Purulia with seizure articles (i) One improvised country made firearms (Iron made) length 14½ inch with iron butt and firing pin (ii) One cartridge, Marked as 'KF' special (iii) One iron rod (iv) Two bamboo sticks to the effect that on 09.10.2023 at about 20.25 hrs received a credible tip off that a gang of dacoits being with deadly armed and weapons as well as fire arms assembled in front of the Purulia Metal Casting Factory at Bongabari under Purulia (M) PS, Dist- Purulia and they were preparing themselves for committing Dacoity at Purulia Metal casting factory. The matter was informed to I.C Purulia (M) PS and noted the information in G.D vide Purulia (M) PS GDE No 451, Dtd. 09.10.2023. On getting the tip off and as per your kind order myself accompanied by ASI Ajoy Mukhopadhyay and force namely (i) C/- 2505 Anup Kundu (ii) C/- 154 Rajib Nag & (iii) C/- 497 Ambuj Kr. Mandal all of Purulia (M) PS vide C.C No- 3949/2023 Dtd. 09.10.2023, immediately proceeded to the anticipated place of assembly to work out the information and reached near the Purulia metal casting factory at 21.45 hrs leaving the Govt. Vehicle started to proceed for the anticipated place on foot. At 22.05 hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that approx 5-7 persons assembled there in the open land in the dark side of a tree and those persons are whispering from which it was clear that they are preparing themselves to commit Dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded in rounding up only 02 (Two) of them at 22.25 hrs and others managed to escape despite a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered (i) one improvised country made firearms (Iron made) length 14½ inch with iron butt and firing pin (ii) one cartridge, Marked as 'KF' special from the back side waist of Sikandar Bauri (28 Yrs) S/o- Mathur Bauri o Purulia Karpurbagan, PS- Purulia (T), Dist- Purulia and (i) one iron rod (ii) Two bamboo sticks from the possession of accused Prasenjit Banerjee (27 Yrs) S/o- Apu Banerjee of Vill- Bongabari near Shiva Mandir, PS- Purulia (M), Dist- Purulia and also searched the place of assembly with torch light but found nothing. Then in between 22.35 to 22.45 hrs from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, I seized (i) One improvised country made firearms (Iron made) length 14½ inch with iron butt and firing pin (ii) One cartridge, Marked as 'KF' special (iii) One iron rod (iv) Two bamboo sticks under proper seizure list as well as labeled duly signed by the apprehended persons and witnesses as Alamat property in c/w above case. On being interrogation they confessed their guilt and they stated that they have assembled there with 5-7 others for committing Dacoity at Purulia Metal casting

factory in which (i) Ramesh (ii) Mithun & (iii) Sambhu all of Purulia Karpur Bagan and others also managed to escape from the spot. I am to note here that I have to conduct search & seizure in presence of Police witnesses as because it was dead hour of night and it was a lonely place and I got information that they assembled and making preparation for committing Dacoity on gun point which might endanger of life of Public witnesses, after the arrest and kept the gun in safe position. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing Dacoity. Hence, I arrested the accused persons namely (i) Sikandar Bauri (28 Yrs) S/o- Mathur Bauri o Purulia Karpurbagan, PS- Purulia (T), Dist- Purulia & (ii) Prasenjit Banerjee (27 Yrs) S/o- Apu Banerjee of Vill- Bongabari near Shiva Mandir, PS- Purulia (M), Dist- Purulia after issuing arrest memos and informing them regarding the grounds of arrest and others formalities is also followed up according to apex Court and guideline of NHRC.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the arrested accused persons namely (i) Sikandar Bauri (28 Yrs) S/o- Mathur Bauri o Purulia Karpurbagan, PS- Purulia (T), Dist- Purulia & (ii) Prasenjit Banerjee (27 Yrs) S/o- Apu Banerjee of Vill- Bongabari near Shiva Mandir, PS- Purulia (M), Dist- Purulia and (iii) Ramesh (iv) Mithun & (v) Sambhu all of Purulia Karpur Bagan, PS- Purulia (T), Dist- Purulia and others under proper section of Law.
