Sir,

In producing herewith the arrested accused driver cum owner namely Golam Mustafa (40 Yrs) S/o- Alijan Momin of Vill- Kukurgoria, PS- Purulia (M), Dist- Purulia along with seized Tractor bearing Reg. No- WB 55 B 5459 attached with sand loaded trolley, Seizure list, Memo of Arrest before you.

The nub of the fact in a nutshell is that on 13.10.2023 while I, ASI Ajoy Mukhopadhyay along with force (i) C/- 699 Biswajit Banerjee (ii) C/- 988 Maheswar kora both of Purulia (M) PS left the PS for performing Spl mobile duty vide Purulia (M) PS GDE No- 685 Dfd. 13.10.2023 in PS area. During my spl mobile duty, I received a tip off at 22:05 hrs that 01 (one) suspicious tractor loaded with sand was coming from Bhul village towards Belkuri Morh. Subsequently, I along with force proceeded towards Belkuri Morh to work out the tip off. While I along with the force arrived at Belkuri Morh on Belkuri Morh-Belkuri village pitch road under Purulia (M) PS, we found that 01 (one) tractor was proceeding towards Belkuri Morh by village road. I along with the force intercepted 01 vehicles (Tractor) having Reg. No- WB 55 B 5459 attached with Trolley is loaded with sand at 22:55 hrs and I found that the vehicle as well as goods were identical as I received prior information. On being asked, the driver of the Tractor disclosed his name as Golam Mustafa (40 Yrs) S/o- Alijan Momin of Vill- Kukurgoria, PS- Purulia (M), Dist- Purulia. I asked the driver cum owner of the Tractor to produce the valid documents in respect of the Tractor as well as the loaded-sand. But the driver cum owner of the said Tractor was not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently at different times. The incoherent statement of the driver cum owner purported to be suspicious to us. It was ascertained that the driver cum owner of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that the alleged driver in cahoots with the owner of the Tractor procured the said sand form Kansai River near Bhul Sand Ghat by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized the Tractor having Reg. No- WB 55 B 5459 attached with Trolley, loaded with sand approx 100 cft under proper seizure list in presence of available witnesses duly signed by them. The seizure was done in between 23:05 to 23.15 hrs. Also arrested the alleged driver namely Golam Mustafa (40 Yrs) S/o- Alijan Momin of Vill- Kukurgoria, PS- Purulia (M), Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. The arrest was made at 23:20 hrs. Thereafter, I brought the seized tractor and alleged arrested driver cum owner to Purulia (M) PS.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the driver cum owner of seized Tractor having Reg. No- WB 55 B 5459 and the arrested driver cum owner namely Golam Mustafa (40 Yrs) S/o- Alijan Momin of Vill- Kukurgoria, PS- Purulia (M), Dist-Purulia under proper section of Law.
