Sub: Prayer for lodging FIR.

Sir,

With due respect I beg to state that; today (14.10.2023) while myself along with force (i) C/- 683 Mansaram Rajak & (ii) NVF- 571 Bhaktaranjan Paramanik both of Purulia (M) PS, Dist- Purulia were engaged in Day Mobile duty vide Purulia (M) PS C.C No- 3993/2023 Dtd. 14.10.2023 and PS GDE No-697 Dtd. 14.10.2023, at about 15.05 hrs I receive an information from my source regarding a huge quantity of illegal stock of coal near Chas morh under Purulia (M) PS. Accordingly, I informed the matter to you and as per your guidance and instruction I along with force had been to the said place at about 15.25 hrs. After that as shown by the source we reached Chas morh, at a shop, beside daily hat and found that about 03 (three) ton of coal is stocking there. But nobody was present there to claim the same coal, except Police personnel. I searched the surrounding area to trace out the owner of said coal, but nobody was found to its ownership.

Made an local enquiry and it is found that Nilkamal Singh @ Budhan S/o- Lt. Dulal Ch. Singh of Vill-Sindri, PO- Sindri Chasmorh, PS- Purulia (M), Dist- Purulia stocked the said coal at the above maintained place for selling the same to make their own profit by dishonestly and they have been running a clandestine business. On preliminary enquiry it could be learnt that they procured the said illegal coal from different places and transported the same in a clandestine manner to another district/state. So, it is reasonable to believe that they were transporting the coal illegally after procuring. Accordingly finding no other alternative way I seized approx 03 (three) Ton of steam coal and one electric weight machine under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list and during seizure I had taken 02 Kg coal from the stoking coal. The seizure was done in between 15.35-15.55 hrs. After that we made a proper arrangement to bring the coal at PS to keep in PS compound.

Therefore, I pray before you that a specific case may kindly be registered under proper section of law against Nilkamal Singh @ Budhan S/o- Lt. Dulal Ch. Singh of Vill-Sindri, PO- Sindri Chasmorh, PS- Purulia (M), Dist- Purulia for illegal stocking of coal at above mentioned place.
