Sub: Prayer for lodging FIR.

Sir,

In producing herewith the seized vehicle (Tractor) having no number plate, Engine No- E3500478 and Chassis No- T053444804BH attached with a Trolley, loaded with sand approx 100 cft and Seizure list.

I beg to state that today (28.10.2023), while myself along with force (i) C/- 2498 Ranjan Kumar Samanta & (ii) HG- 1405 Kailash Mahato all of Purulia (M) PS are performing day mobile duty vide Purulia (M) PS GDE No- 1398 Dtd. 28.10.2023 at Purulia (M) PS area. During my mobile duty, at 13.05 hrs, I received information from a source that a suspicious tractor loaded with sand was coming from Anai Jambad Ghat (Kasai River). Accordingly, I informed the matter to you and as per your directions, I along with force proceeded towards that place to work out the information. While I, along with the force, arrived near Biltora village on Amjora to Biltora pitch road under Purulia (M) PS we are found 01 (one) tractor attached with a trolley loaded with sand standing on that place. I along with the force intercepted the vehicle (Tractor) having no number plate, Engine No- E3500478 and Chassis No- T053444804BH, attached with a Trolley, loaded with sand approx 100 cft without a driver or any other person, at 13.35 hrs and I found the vehicle as well as goods identical as I received prior information. I moved through the surrounding area to trace the said driver or owner of the detained tractor but nobody was found to stand its ownership. During the primary enquiry it was found that the owner and driver of the said vehicle loaded the said sand by illegal means to sell the same to make their own profit by dishonestly and they had been running a clandestine business. It is reasoned to believe that the driver in cahoots with the owner of the vehicle and others procured the said sand from the Kansai River under Purulia (M) PS side by fraudulent means or theft by any means to transport the same to run a clandestine business.

Accordingly, finding no other alternative way I seized the (tractor) having no number plate, Engine No- E3500478 and Chassis No- T053444804BH attached with a Trolley, loaded with the sand 100 cft (approx) under proper seizure list. The seizure was made between 13.45 and 14.15 hrs in presence of the available witnesses duly signed by them. Thereafter, I brought the said seized tractor to Purulia (M) PS compound for safe custody.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the driver and owner of the seized vehicle (Tractor) having no number plate, Engine No- E3500478 and Chassis No- T053444804BH, attached with a Trolley, loaded with sand under the proper section of Law.
