Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested alleged stockiest namely Sunil Kumar Mahata (61 Yrs) S/o- Lt. Nandalal Mahata of of Vill- Golbera, PS- Purulia (M), Dist- Purulia and seized red colour TOTO without registration number loaded with approx 05 (five) Ton coal in 18 (eighteen) plastic sacks and also taken sample of 02 kg coal from the TOTO.

With due respect I beg to state that; today (29.10.2023) while myself along with force (i) C/- 2409 Binayak Dubey and (ii) C/982- Shyamal Rajwar both of Purulia (M) PS, Dist- Purulia were engaged in Special Mobile duty at Imundi Xing vide Purulia (M) PS C.C No- 5028/2023, Dated. 29.10.2023 and PS GDE No-1481 Dated. 29.10.2023, at about 18.15 hrs I receive an information from my source that 1) Sunil Kumar Mahata (61 Yrs) S/o- Lt. Nandalal Mahata, 2) Dulal Mahata s/o Saur Mahata both of Vill- Golbera, PS- Purulia (M), Dist- Purulia have been running a clandestine business of stocking and selling of illegal coal to make their own profit by dishonestly at a yard beside the house of Dulal Mahata s/o Saur Mahata of Vill- Golbera, PS- Purulia (M), Dist- Purulia. They have loaded illegal coal in a red colour TOTO at above noted. Accordingly, I informed the matter to you and as per your guidance and instruction I along with above noted force had been to the said place at about 18:45 hrs. After that I found that illegal stock of coal has been loaded in a red colour TOTO at the above noted place.

On preliminary enquiry it could be learnt that they procured the said illegal coal from different places and transported the same in a clandestine manner to another places. So, it is reasonable to believe that they were transporting the coal illegally after procuring. Accordingly finding no other alternative way I seized 1) approx 05 (five) Ton coal in 18 (eighteen) plastic sacks loaded in a red colour TOTO without registration number, 2) electric weighing machine under proper seizure list duly signed by above noted accused person and the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list and during seizure I had taken 02 Kg coal from the stoking coal. The seizure was done in between 19:05-19.25 hrs. Next I arrested Sunil Kumar Mahata (61 Yrs) S/o- Lt. Nandalal Mahata of of Vill- Golbera, PS- Purulia (M), Dist- Purulia after maintaining all formalities regarding arrest at 19:35 hrs. I also issued check list. Dulal Mahata s/o Saur Mahata of Vill- Golbera, PS- Purulia (M), Dist- Purulia managed to escape to avoid police arrest. After that we made a proper arrangement to bring the coal loaded in a red colour TOTO and other seizure article at PS to keep in PS compound and PS Malkhana.

Therefore, I pray before you that a specific case may kindly be registered under proper section of law against 1) Sunil Kumar Mahata (61 Yrs) S/o- Lt. Nandalal Mahata, 2) Dulal Mahata s/o Saur Mahata both of Vill- Golbera, PS- Purulia (M), Dist- Purulia for illegal stocking and selling of coal at above mentioned place.
