

POLICE

I beg to state that on 29.10.2023 at about 19.15 hrs while I, SI Shoumik Acharyya along with (i) C/- 178 Tulsi Mahato & (ii) C/-1137 Sridam Bauri both of Purulia (M) PS, Dist- Purulia vide Purulia (M) C.C No- 5022/2023 Dtd. 29.10.2023 and PS GDE No-1450 Dtd. 29.10.2023 were performing mobile duty at PS area I received information from my source that one Pick Up Van having registration No- WB55A/1600 loaded with illegal coal is going towards Bamro- Kanali village road. After receiving the information I contacted to I/C Purulia (M) PS and as per guidance and instruction we chased the Bolero Pick Up Van having registration No- WB55A/1600. After a long chase I managed to stop the vehicle Bamro- Kanali village road near Bamro village under Purulia (M) PS at about 19.15. On seeing the Police party the driver who was also the owner namely Shibaprasad Gorai S/o- Lt. Sanaram Gorai of Vill-Bamro, PS-Purulia (M), Dist-Purulia of the vehicle tried to flee away but we managed to apprehend him. On being asked the apprehended person disclosed his identity noted above. On demand he failed to produce any valid document in respect of loaded coal. On preliminary enquiry it could be learnt that the driver who is also the owner of the said vehicle was procuring the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. So, it is reasonable to believe that he was transporting the coal illegally after procuring.

Accordingly I seized the above noted vehicles loaded with coal approx 20 (Twenty) TON under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list during seizure. I have taken 02 Kg coal from the Pick Up Van as sample after preparing proper level. The seizure was made between 19.35 to 19.55 hrs. I also arrested the above noted accused person at 20.05 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. After that we made a proper arrangement and brought the arrested accused and seized vehicle loaded with coal at PS for custody.

Therefore, I pray before you that a specific case may kindly be registered against the driver namely Shibaprasad Gorai S/o- Lt. Sanaram Gorai of Vill- Bamro, PS- Purulia (M), Dist- Purulia and the owner of the seized Pick Up Van having registration No- WB55A/1600 under proper section of law.
