Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Ashok Dubey (55 Yrs) S/o- Rasaraj Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia and seized articles 19 (Nineteen) sealed bottles of 'DIL KHUSH' containing 600 ml each, along with seizure list, Memo of Arrest.

I beg to state that today (20.10.2023) evening while I, ASI Nirod Kumar Mahato along with force (i) C/- 683 Mansaram Rajak & (ii) C/- 994 Srikanta Kumbhakar all of Purulia (M) PS vide GDE No- 1048 Dtd. 20.10.2023 were performing mobile duty. During my mobile duty, at about 16.45 hrs I received a secret tip off that an illegal possession of a huge quantity of liquors. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at the grocery shop situated at Shibdih village under Purulia (M) PS and after arriving at the spot and as per your instruction conducted raid in the said grocery shop at about 17.25 hrs. During the raid some people fled away and detained one person. On being asked he disclosed his identity as Ashok Dubey (55 Yrs) S/o- Rasaraj Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he stocks the liquors for selling illegally in his grocery shop. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors from his grocery shop. Subsequently, I seized 19 (Nineteen) sealed bottles of 'DIL KHUSH' containing 600 ml each. In which one sealed bottles were taken as samples from each item. I seized the same under proper seizure list in presence of witnesses, duly signed by the witnesses and accused person. The seizure was made at 17.35 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Accordingly, I arrested the involved accused person namely Ashok Dubey (55 Yrs) S/o- Rasaraj Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia at 17.40 hrs after maintaining all formalities regarding arrest and NHRC guidelines, issued Memo of Arrest. Informed him regarding the ground of arrest and also informed his family members.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Ashok Dubey (55 Yrs) S/o- Rasaraj Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia under proper section of Law.
