Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Raju Pandey (25 Yrs) S/o- Nirmal Pandey of Vill- Imundih, PS- Purulia (M), Dist- Purulia and seized articles 25 (Twenty Five) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each, along with seizure list and Memo of Arrest.

I beg to state that today (22.10.2023) evening while I, SI Subrata Sarkar along with force (i) C/- 154 Rajib Nag & (ii) C/- 2409 Binayak Dubey all of Purulia (M) PS vide GDE No- 1119 Dtd. 22.10.2023 were performing mobile duty. During my mobile duty, at about 17.25 hrs I received secret information regarding an illegal possession of a huge quantity of liquors. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot Road Way Line Hotel situated at Maguria area under Purulia (M) PS and after arriving at the spot and as per your instruction conducted raid in the Road Way Line Hotel situated at Maguria near Shankar Petrol Pump beside the Pitch Road from Purulia to Ranchi at about 18.05 hrs. During the raid some people fled away and detained one person. On being asked he disclosed his identity as Raju Pandey (25 Yrs) S/o- Nirmal Pandey of Vill- Imundih, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he is the worker of said Hotel. He also stated that the owner of the said Line Hotel namely Babu Shao (M- 7908154102) of Surya Sen Pally Purulia, PS- Purulia (T), Dist- Purulia stocks the liquors for selling illegally in his Line Hotel. So that he could gain more amounts from the selling of liquors. During the raid the owner fled away. On demand the arrestee failed to produce any valid document in respect of selling and possession of said liquors in this Line Hotel. Subsequently, I seized 25 (Twenty Five) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each. In which one sealed bottle was taken as a sample. I seized the same under proper seizure list in presence of witnesses, duly signed by the witnesses as well as the arrested accused person. The seizure was made at 18.15 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Accordingly, I arrested the involved accused person namely Raju Pandey (25 Yrs) S/o- Nirmal Pandey of Vill- Imundih, PS- Purulia (M), Dist- Purulia at 18.25 hrs after maintaining all formalities regarding arrest and NHRC guidelines, issued Memo of Arrest. Informed him regarding the ground of arrest and also informed his family members.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Raju Pandey (25 Yrs) S/o- Nirmal Pandey of Vill- Imundih, PS- Purulia (M), Dist- Purulia & the owner of said Line Hotel namely Babu Shao (M- 7908154102) of Surya Sen Pally Purulia, PS- Purulia (T), Dist- Purulia under proper section of Law.
