Respected Sir,

In producing herewith the arrested accused driver namely Dipak Sardar (24 yrs) S/O- Bibhisian Sardar of Vill- Satsimulia, PO- Kotlui, PS- Tamna, Dist- Purulia & along with seized vehicle (Tractor) Bearing Reg. No. WB56U-4206 attached with Sand loaded Trolley without any number Plate and with Seizure list, Memo of Arrest and Inspection Memo in respect of the above noted persons before you.

I beg to report that today (07.10.2023) at 03:45 hrs while I along with force 1) C/893 Koushik Keriar 2) HG/333 Nakul Gorain along with motor Cycle team leaded by C/2041 Uttam Man all are of Purulia (T) PS was performing night mobile duty vide Purulia (T) PS CC No 3449/2023 and GDE No 357 Dt. 06.10.2023 in PS area. During my night mobile duty, I received information that a suspicious tractor loaded with sand was coming from Simulia side towards Dulmi Nadiha. Subsequently, I along with force proceeded towards end of our P.S area to work out information. While I along with force arrived near at Dulmi Near Shib Mandir Goli under Purulia (T) PS and found that 01 (one) tractor was coming towards Dulmi Nadiha. I along with force intercepted the vehicle (Tractor) bearing No. WB56U-4206 attached with sand loaded trolley without any number plate and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of said vehicle disclosed his name as noted above. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor as well as carrying sand. I repeatedly asked the driver to produce the valid paper but he stated in coherent statement in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand form Kansai River under Tamna PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, detained the tractor and driver and asked to produce valid document in respect of loaded sand in tractor but he failed to produced any documents till 10:00 hrs dated 07.10.2023 so I seized the (tractor) Bearing No WB56U-4206 attached with Trolley loaded with Sand without any number plate under proper seizure list in between 10:05 hrs to 10:15 hrs. in presence of available witnesses duly signed by them and also arrest the driver namely Dipak Sardar (24 yrs) S/O- Bibhisian Sardar of Vill- Satsimulia, PO- Kotlui, PS- Tamna, Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Purulia (T) PS compound.

Under the above facts and circumstances I beg to pray kindly take lawful action against the owner of the tractor bearing No. WB56U-4206 and the arrested driver of the tractor namely Dipak Sardar (24 yrs) S/O- Bibhisian Sardar of Vill- Satsimulia, PO- Kotlui, PS- Tamna, Dist- Purulia of the vehicle as they committed offence U/S 379/411/414 of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
