Sir,

In producing herewith one arrested accused person namely Subhas Bauri (57 Yrs) S/O- Late Kanai Bauri of Ketika, Bauripara, Ward No- 09, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

- (1) 16 (Sixteen) bottles of Country Spirit styled as 'Dil Khush' containing 600 ml each bottles.
- (2) Out of 16 (Sixteen) bottles 01(one) bottle is kept as sample.

I, ASI Tapan Mahanty, beg to report that while I was performing RT mobile duty vide Purulia (T) PS GDE No 741 dated 12.10.2023, at about 19:45 hrs received a secret telephonic information from source that one Subhas Bauri S/O- Late Kanai Bauri of Ketika, Bauripara, Ward No- 09, PS-Purulia (T), Dist. - Purulia is selling country spirit illegally at a higher price to the customers causing unlawful gain at his house at Ketika, Bauripara.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of HG/1442 Shanti Kundu and HG/333 Nakul Gorai all of Purulia (T) PS proceeded to work out the information.

At 20:15 hrs we reached at Ketika, Bauripara and keeping our Govt. vehicle at a reasonable distance we proceeded towards the house of above noted Subhas Bauri as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them fled away from the spot. On hot chase seller could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of shop we found 16 (Sixteen) bottles of Country Spirit styled as 'Dil Khush' containing 600 ml each bottles. As such in between 20:25 hrs to 20:45 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrest him at 20:55 hrs observing all the formalities regarding arrest as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
