Respected Sir,

In producing herewith one (1) Sarfaraj Khureshi @ Hairan (18Yrs) S/O- Aktar Khureshi of Digudih para Ward-08, P.S- Purulia(T), Dist- Purulia,(2) Ajijul Molla(33Yrs) S/O- Aasraf Molla of Vill- Madhabpur, P.S- Bhangore, Dist- South 24 Pgs and (3) Sk Altab (50yrs) S/O- Late Sk Daliuddin of 166 Becharam Chatterjee Road, P.S- Parnashree, Dist- South 24 Pgs with seized articles under proper seizure lists which were duly signed by the accused persons as well as the witnesses.

Today (15.10.2023) at 13:05 hrs. myself received an information that one Hairan @ Sarfaraj Khureshi started a Codeine Mixture business near Dak Bungalow under Purulia Town PS. I diarized the matter vide G.D.E No- 918 Dated 15.10.2023 and informed IC Purulia Town PS. Myself along with other available officers and force accompanied with IC Purulia Town PS to work out the information with carbon paper, seizure list, white paper, stamp and gala and investigation kit box. I would like to mention here that IC Purulia Town PS informed SDO Sadar Purulia for an Executive Magistrate to accompany with us to work out the above noted information. We waited 15 minutes but nobody came to PS, IC Purulia Town PS further informed the SDO Sadar Purulia for providing an Executive Magistrate and requested him to sending the Executive Magistrate near Dak Bungalow, Purulia. After that myself and others left for Dak Bungalow by Govt. vehicle bearing No- WB 56 C 5421. We reached the Dak Bungalow near Purulia Rly. Station and found that one person identified by the source as Hairan @ Sarfaraj Khureshi sitting inside an abandon store from where he is selling some illegal Codeine Mixture which used for as drug. We able to cordon him and disclosed our identity that we are police personnel of Purulia Town PS. Executive Magistrate was not available that very time and today is Sunday. As a Gazette officer, IC Purulia Town PS offered him to search our person in presence of the local witnesses, but the said Hairan @ Sarfaraj Khureshi did not agree, then I searched him as well as his surrounding places in presence local available witnesses and I found one white plastic jar which containing liquid which seems as contraband like substance (Codeine Mixture). At the time of the opening cap of the jar aromatic smell coming out from the jar on demanding Hairan @ Sarfaraj Khureshi failed to produce any valid papers/documents in respect of the contraband substance (Codeine Mixture). During interrogation, Hairan @ Sarfaraj Khureshi stated that very recent he started this illegal business with help of some persons who are coming from Kolkata and supply this contraband substance. On asking he stated that today i.e. 15.10.2023 they will come Purulia Bus Stand from Kolkata to supply the contraband substance (Codeine Mixture). If I give him a chance he will assist us to identify them. There after myself seized the contraband substance which containing in a white plastic jar with red cap total weight 2 K.G (liquid) out of which three sample contains 100 grams Codeine Mixture mark as Exhibit A1, A2 and A3 then the weight of mother sample 01 Kg 700 grams mark as **Exhibit A (Mother Sample)**. I prepared seizure and labeled at the spot in presence of the local witnesses. I weight the seized articles with the help of local business man one Kamal Bauri S/O- Late Bimal Bauri of Sinderpatty Ward No-10, P.S- Purulia (T), Dist-Purulia. I used his weighing machine and he was one of the witnesses of the seizure list. IC Purulia Town PS who was physically present during the process and he also act as Gazette Officer due to non availability of Executive Magistrate.

On interrogation Hairan @ Sarfaraj Khureshi also stated that he will assist us to identify the persons who supplied this contraband substance (Codeine Mixture). I arrested Hairan @ Sarfaraj Khureshi maintaining all formalities and copy of seizure list and arrest memo issued him.

There after myself and others left for Purulia Bus Stand with Hairan @ Sarfaraj Khureshi. After waiting few minutes arrested accused Hairan @ Sarfaraj Khureshi identified & indicating three persons who are coming with one Nylon big size bag. Seeing the police party one able to escape from the spot. I immediately cordon them and on asking they disclosed their identity as (1) Sk Altab(50yrs) S/O- Late Sk Daliuddin of 166 Becharam Chatterjee Road, P.S- Parnashree, Dist- S 24 Pgs (2) Ajijul Molla(33Yrs) S/O- Aasraf Molla of Vill- Madhabpur, P.S- Bhangore, Dist- S 24 Pgs. I offered them to search our persons but they refused. I searched their persons and seized the nylon bag which containing one plastic jar. IC Purulia Town PS was physically present and he act as a Gazette Officer. On asking they failed to produce any valid papers in respect of the contraband substance Codeine Mixture. I open the cap of the jar and aromatic smell coming out from the jar. They stated different statements at different times, at last they confessed that the person who managed to flee away from this spot, his name is Siraj Naskar S/O- Akkaz Naskar of Natagachi, Beniabow, Dist- S 24Pgs, if I will give chance they will help me to arrest him. I prepared seizure list in presence of local witnesses and weighted the seized contraband item/ substance of local fruit seller of the Purulia Bus Stand namely Sk Israk S/O- Late Sk. Siddik of Vill- Tantari, P.S- Purulia (M), Dist- Purulia and others. The whole process was properly videographed. IC Purulia Town and other local witnesses put their signature during seizure and labeling. I weight the white plastic jar which fully loaded with Codeine Mixture, the total weight of the plastic jar was 5 kg 200 gram out of which I collected three separate sample (100 gram) each mark as Exhibit B1, B2 and B3. The mother sample was weight and result came out as 4 kg 900 gram and marked as **Exhibit B**. Thereafter I arrest Sk Altab and Ajijul Molla. The entire search and seizure process properly videographed.

Hence there is reasonable to believe that above noted 03 (Three) accused persons i.e. (1) Sarfaraj Khureshi @ Hairan (18Yrs) S/O- Aktar Khureshi of Digudih para Ward-08, P.S- Purulia(T), Dist- Purulia (2) Sk Altab (50yrs) S/O- Late Sk Daliuddin of 166 Becharam Chatterjee Road, P.S- Parnashree, Dist- South 24 Pgs (3) Ajijul Molla (33Yrs) S/O- Aasraf Molla of Vill- Madhabpur, P.S- Bhangore, Dist- South 24 Pgs and (4) Siraj Naskar S/O- Akkaz Naskar of Natagachi, Beniabow, Dist- South 24 Pgs are liable for prosecution U/S- 21(c)/29 NDPS Act 1985 as amended up to date.

Under these circumstances, I request you to initiate a case against 03 (Three) persons i.e. (1) Sarfaraj Khureshi @ Hairan (2) Sk Altab (50yrs) (3) Ajijul Molla (33Yrs) and (4) Siraj Naskar U/S- 21(c)/29 NDPS Act 1985 as amended up to date and arrange for its proper investigation.
