Subject: - FIR against user Anand Maheswari, Son of Purusottam Maheswari, resident of Muchl Para, Near Karani Dharmasala, Purulia Town Police Station, Dist Purulia.

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused has committed interference with meter or work of licensee U/S 138(b) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 05/10/2023 at 15.30 Hrs. I, Sri Subhajit Pratihar DE & SM Purulia CCC WBSEDCL along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL), Promod Ranjan Barman (Special officer attached to Purulia Regional Office, Chinmay Maity (JE Purulia CCC), Anurag Pandey (OE Purulia CCC), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) and Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding unauthorized reconnection of a service connection bearing consumer id no 242115555 in the name of ~~late~~ Banarasi Debi resident of Muchl Para, Near Karani Dharmasala, Purulia. The service connection was disconnected by WBSEDCL on 02.02.2023 due to non-payment of outstanding bill and unauthorized reconnection. One FIR was lodged against the offence under section 138(b) vide FIR no 24/23 dated 02.02.2023. One assessment bill against the theft amounting to Rs 429490.00 was served to Anand Maheswari, but he did not paid the amount. Now, as on today the outstanding is Rs 461941.86 excluding applicable late payment surcharge as per regulation. The service connection is in deemed disconnected status in our database. The team entered the premises by serving one entry notice duly signed by the consumer Banarasi Debi.

During the time of inspection at the domestic premises 1 nos of electricity meter was found having serial no IPBB27272 (Consumer id 242115555, Consumer Name- Banarasi Debi). The meter was connected to the mains through a service cable. The user was enjoying electricity service and the reading on the meter was recorded 30939 KWH.

In presence of the inspection team and the user it was observed that user Anand Maheswari has made unauthorized reconnection of the service connection bearing consumer id no 242115555 and has made second offence under section 138 (b). Accused has made huge financial loss to WBSEDCL.

After detection of unauthorized reconnection of service line illegally and dishonestly, the inspection team disconnected the service line in the premises from pole with the help of LT Mobile Van Team and seized the service cable.

The inspection team left the premises at about 15:45 Hrs on 05th Oct 2023.

The accused committed interference with meter or work of licensee under section 138(b) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
