Sir,

In producing here with arrested accused persons namely (1) Md. Sanwaz Alam @ Md. Roja (22 yrs) S/O- Md. Mustakim Alam of Rail Par, Musaddi Mohalla, Asansol, PS- Asansol (North), Dist- Paschim Bardhaman, (2) Md. Amir (20 yrs) S/O- Md. Mobin of Rail Par, Musidhi Mohalla, Asansol, PS- Asansol (North), Dist- Paschim Bardhaman and (3) Aftab Ansari (33 yrs) S/O- Shabuddin Ansari of Muslim Para, R.K. Mission Bye Lane, Asansol, (M. Corp.), PS- Asansol (South), Dist- Paschim Bardhaman and seized articles (1) One bhojali with wooden butt length approx 10 inch out of which 06 inch sharpen portion and 4 inch butt (2) One Iron made Chopper length 8 inch, (3) One Khukri with plastic butt length 10 inch out of which 6 inch sharpen portion and 4 inch plastic butt lodged complaint against them and some others to the effect that on 05.10.2023 at about 21:35 hrs in course of 2nd Special Mobile Duty vide Purulia (T) PS GDE No- 270 dated - 05.10.2023 and C.C. No- 3440/2023 dated - 05.10.2023 received a credible tip from duty officer of Purulia (T) PS which was noted vide Purulia (T) GDE No- 296 dated - 05.10.2023 that a gang of dacoits being armed with deadly weapons assembled at Ketika Railway Colony Ground, Ward No- 09 and they were preparing themselves for committing dacoity at Ketika. Accordingly as per direction of I/C Purulia (T) PS and duty officer over phone myself along with HG/333 Nakul Gorai and HG/1454 Prakash Char and PC Party team proceeded to work out the information by a Govt. vehicle, and reached near Ketika Railway Colony ground at 21.45 hrs reached at anticipated place and we noticed in a glimpse of light that a gang of 10/12 persons assembled at Ketika Railway Ground and those persons were whispering from which it was clear that they were preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very closely. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed to ours words and tried to flee away. We succeeded to nab in rounding up only 03(three) of them at 21:55 hrs while the rest were managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them that we want to search them and if necessary they can search us, but they informed us that they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered and seized (1) One bhujali with wooden butt length approx 10 inch out of which 06 inch sharpen portion and 4 inch butt from the possession of Md. Sanwaz Alam @ Md. Roja (2) One Iron made Chopper length 8 inch from the possession of Md. Amir (3) One Khukri with plastic butt length 10 inch out of which 6 inch sharpen portion and 4 inch plastic butt from the possession of Aftab Ansari and also seized one rough sketch map of Ketika area from the place where they assembled in between 22:05 hrs to 22:15 hrs. I arrested above noted 03 (three) persons. Issued Memo of arrest and observe all legal formalities of arrest, also inform them regarding ground of arrest and inform to their family members. On interrogation they confessed their guilt and they stated that they have assembled there along with associates namely Sumit Barman @

Bangali (24yrs), S/O- Rajesh Barman, of Old Police Line More, Near Amru Sweet Shop, Ward No- 14, PS- Purulia (T), Dist- Purulia and Md. Mannan Kureshi @ Md Mannan, S/O- Lt. Md. Seru Kureshi @ Md Sheru of Kasaidanga, Ward No- 08, PS- Purulia (T), Dist- Purulia and others for committing dacoity at Ketika area.

I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity armed with deadly weapons which might be dangerous for life of public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities, I arrested them after preparing arrest memo and ground of arrest were duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Md. Sanwaz Alam @ Md. Roja (22 yrs) S/O- Md. Mustakim Alam of Rail Par, Musaddi Mohalla, Asansol, PS- Asansol (North), Dist- Paschim Bardhaman, (2) Md. Amir (20 yrs) S/O- Md. Mobin of Rail Par, Musidhi Mohalla, Asansol, PS- Asansol (North), Dist- Paschim Bardhaman and (3) Aftab Ansari (33 yrs) S/O- Shabuddin Ansari of Muslim Para, R.K. Mission Bye Lane, Asansol, (M. Corp.), PS- Asansol (South), Dist- Paschim Bardhaman along with associates namely Sumit Barman @ Bangali (24yrs), S/O- Rajesh Barman, of Old Police Line More, Near Amru Sweet Shop, Ward No- 14, PS- Purulia (T), Dist- Purulia and Md. Mannan Kureshi @ Md Mannan, S/O- Lt. Md. Seru Kureshi @ Md Sheru of Kasaidanga, Ward No- 08, PS- Purulia (T), Dist- Purulia and others under proper section of law.
