Sir,

In producing herewith the arrested accused person namely Kartick Gorai (42) S/o Laur Gorai of Vill.- Bamarrah, PS – Raghunathpur, Dist.- Purulia and seized 05 (Five) Nos. two wheelers loaded with total 15 Qntls. (Approx) steam coal and approx 10 Qntls. steam coal from stock point which is situated river side of Damodar near Kargali Ghat. Fact of the case in brief is that on 14.10.2023 myself along with C/1517 Tinkori Chakraborty and NVF/1053 Sanjoy Karmakar were performing evening mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2681/23. On 14.10.2023 at about 20:25 hrs. received a credible source information that some persons were loaded coal in two wheelers with a view to illegal transporting from river side of Damodar near Kargali Ghat under Raghunathpur PS. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Kargali Ghat. Then we have cordoned the place by our police personnel and found that some persons having loaded coal in two wheelers from river side of Damodar near Kargali Ghat under Raghunathpur PS, at that time we were able to apprehend 05 (Five) Nos. of two wheelers vide (1) One Yellow colour Hero Passion Plus bearing Reg. No. WB 38R/8265 loaded with approx 03 (three) Qntls. Coal in plastic bag, (2) One Black colour Bajaj Kawasaki bearing Reg. No. WB 56C/2575 loaded with approx 03 (three) Qntls. Coal in plastic bag, (3) One Red Colour Suzuki without number plate loaded with approx 03 (three) Qntls. coal in plastic bag, (4) One Green colour Vespa without number plate loaded with approx 03 (Three) Qntls. coal in plastic bag, and (5) One Sky colour Vespa without number plate loaded with approx 03 (three) Qntls. coal in plastic bag and 01 (one) rider as noted above and 04 (four) riders have been fled away among 05 (five) intercepted two wheelers. On asking the rider of the said two wheeler failed to produce any papers in respect of said loaded Steam Coal as well as papers in respect of two wheelers. He also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those two wheelers collected the said steam coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation the above noted person confessed his guilt and illegal steam coal has been transported by the other riders with helper namely (1) Uttam Hazra S/o Alok Hazra, (2) Babu Hazra S/o Siddeswar Hazra, (3) Ruplal Mandal S/o Bidesh Mandal, (4) Mukta Mandal S/o Batul Mandal, (5) Shyamal Mandal S/o Dwijapada Mandal, (6) Milan Mandal S/o Gopal Mandal all are Vill.- Kargali, PS – Raghunathpur, Dist.- Purulia, who fled away from the PO. As such it is every reason to believe that those persons along with two wheelers are transporting the said steam coal illegally. I seized above 05 (Five) Nos. two wheelers loaded with Coal and approx 10 Qntls. steam coal from stock point which is situated river side of Damodar near Kargali Ghat under proper seizure list duly signed by the accused person and witnesses. I also arrested accused Kartick Gorai (42) S/o Laur Gorai of Vill.- Bamarrah, PS – Raghunathpur, Dist.- Purulia after observing all formalities and narrating his ground of arrest. No

public witnesses were turned up there. Approx 01 (One) K.G. of Steam Coal in each two wheelers collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the accused person namely (1) Kartick Gorai (42) S/o Laur Gorai of Vill.- Bamarrah, PS – Raghunathpur, Dist.- Purulia, (2) Uttam Hazra S/o Alok Hazra, (3) Babu Hazra S/o Siddeswar Hazra, (4) Ruplal Mandal S/o Bidesh Mandal, (5) Mukta Mandal S/o Batul Mandal, (6) Shyamal Mandal S/o Dwijapada Mandal and (7) Milan Mandal S/o Gopal Mandal all are Vill.- Kargali, PS – Raghunathpur, Dist.- Purulia as per law and arrange for its investigation.
