Sir,

In producing here with 02 (two) arrested accused persons namely (i) Aratatrana Sahoo (31Y) (Driver), S/O Lt. Budhumanta Sahoo & (ii) Tuna Sahoo (32Y) (Khalasi), S/O Lt. Parikshit Sahoo both of Vill. -Himitira, PS - Rajkishorenagar, Dist. - Anugul, State - Odisha and 01 (One) Truck bearing registration No. OD04K/5595 loaded with 24.15 MT coal under proper seizure. I beg to submit that today (10/10/2023)while I, along with C/1406 Raj Kumar Lohar & C/586 Bholanath Dey, were performing special mobile duty vide Santaldih PS GDE no. 420, dated 10.10.2023, at Santaldih PS area and at 14:15 hrs I received a credible source information about illegal coal transportation from Chandankiyari side towards Paharigora. Accordingly I informed the matter to IC Santaldih PS and as per his direction I along force of Santaldih PS went out for executing the credible source information about illegal transportation of coal. At about 14:35 hrs when we reached at Paharigora more found that the above noted truck is coming from Chandankiyari side towards Paharigora side. We chased the truck but seeing the police persons the driver tried to flee away with truck loaded with coal and somehow we apprehended them. I asked the above noted driver Aratatrana Sahoo to produce relevant documents regarding procurement of the loaded coal but he could not produce the same. He only produced one challan of the weight of the coal and its perusal it is found 24.150 MT. We also searched the truck and found that the truck is loaded with coal. After finding no other alternative I seized the truck bearing Regd. No. OD04K/5595 approx 24 (Twenty four) MT steam coal in between 14:55 hrs to 15:15 hrs. under proper seizure list in presence of witnesses duly signed by them. No public witness was available there. I also arrested the above noted accused persons at 15.45 hrs maintaining all arresting guidelines. After that we arrange for transporting the truck from the PO and brought the seized coal loaded truck at Santaldih PS and kept the truck at PS compound and put the arrested accused persons in PS lock up. I also informed it to IC Santaldih PS. I have also seized 1 KG coal from the said seized coal loaded truck as sample at the PO.

On secret enquiry through my reliable source it came to light that the owner and driver of the above noted truck with their full knowledge and consent running this clandestine business by means of illegal transportation of coal for their wrongful gain.

Hence I do here by lodge this complaint with a prayer that a specific case may be started against the above noted arrested persons along with the owner of the truck bearing registration no. OD04K/5595 under proper section of law and arrange for its investigation.
