

Sir,

I, Jagannath Rakshit S/o- Subodh Ch. Rakshit of Vill- Paisabad, PS- Chhatna, Dist-Bankura, at present posted under Tamna PS, Dist-Purulia as ASI of Police producing here with the arrested accused persons namely (i) Arup Gope (21 yrs ) S/O- Sakhu Gope (ii) Bhaghya Rajak (41 yrs) S/O- Lt. Haradhan Rajak (iii) Bablu Gope (26 yrs) S/O- Lt. Jagtu Gope (iv) Nibaran Gope (32 yrs) S/O- Satya Gope (v) Mukta Ram Kumar (32 yrs) S/O- Lt. Kristapada Kumar (vi) Shibaram Gope (31 yrs) S/O- Bhakta Gope & (vii) Hiralal Gope (33 yrs) S/O- Lt. Kalipada Gope all are Vill-Bazra, PO- Puriara, PS-Barabazar, Dist- Purulia along with seized articles, to the effect that on 06/10/2023 at about 11.25 hrs received credible source information that some persons were shorting the iron chips, manganese and stocked beside Deben Mahato Line Hotel at Karamara under Tamna P.S. The matter was informed to O/C Tamna PS and as per his direction myself along with force immediately reached near Deben Mahato Line Hotel at Karamara under Tamna PS and found that 10-12 persons were commuted theft iron Chips, Manganese from loaded trucks with the help of drivers of the said truck and stocked illegally at godown of Vicky Jain @ Bibek Kr. Jain beside Deben Mahato Line Hotel at Karamara under Tamna PS. Seeing the Police party they tried to flee away, but we apprehended the above noted person and remaining persons are manage to escape despite of a hot chasse. On interrogation they disclosed their identity as mentioned above, so I arrested (i) Arup Gope (21 yrs ) S/O-Sakhu Gope (ii) Bhaghya Rajak (41 yrs) S/O- Lt. Haradhan Rajak (iii) Bablu Gope (26 yrs) S/O- Lt. Jagtu Gope (iv) Nibaran Gope (32 yrs) S/O- Satya Gope (v) Mukta Ram Kumar (32 yrs) S/O- Lt. Kristapada Kumar (vi) Shibaram Gope (31 yrs) S/O- Bhakta Gope & (vii) Hiralal Gope (33 yrs) S/O- Lt. Kalipada Gope all are Vill-Bazra, PO- Puriara, PS-Barabazar, Dist-Purulia. They stated that one Vicky Jain is the owner of the godown. I asked them to call Vicky Jain but no one come since long time and also asked them to produced valid documents in respect of staged articles. They failed to produce any valid documents. So, there is every reason to belief that the owner and others are dealing this business in clandestine manner. So I arrested (i) Arup Gope (21 yrs ) S/O- Sakhu Gope (ii) Bhaghya Rajak (41 yrs) S/O- Lt. Haradhan Rajak ( iii) Bablu Gope (26 yrs) S/O- Lt. Jagtu Gope (iv) Nibaran Gope (32 yrs) S/O- Satya Gope (v) Mukta Ram Kumar (32 yrs) S/O- Lt. Kristapada Kumar (vi) Shibaram Gope (31 yrs) S/O-Bhakta Gope & (vii) Hiralal Gope (33 yrs) S/O- Lt. Kalipada Gope all are Vill-Bazra, PO-Puriara, PS-Barabazar, Dist-Purulia after issuing memo of arrest and observing legal formalities of arrest and seized (i) One vehicle (Truck) having reg. No. WB-55A/5650 loaded with 50 (fifty) plastic gunny bags filled with iron granules @ of 50 KG per beg (ii) One vehicle (Truck) having reg. No. JH-05Z/5877 loaded with quater dala manganese ore (iii) 62 (sixty-two) plastic gunny bags filled with iron granules Sponge iron approx 50 KG per beg (iv) 20 (twenty) bags plastic gunny bags filled with iron ore @ approx 50 KG per beg (v) 08 (eight) bags (plastic) filled with manganese ore after preparing seizure list duly signed by the witnesses. After completion of all process, myself along with force brought arrested accused persons and seized articles.

Therefore, I do hereby lodge this complaint against the above noted arrested accused persons and owner of the go-down who fled away, hence they have committed theft, purchase and dealing stolen property.
