Respected Sir,

I, Sk. Amanur S/O- Sk. Anish of Vill- Bishalpur, P.O- Tapaspur, PS- Sadaipur, Dist- Birbhum, at present posted at Tamna PS, Dist-Purulia as SI of Police producing herewith one arrested accused person namely Shibaram Mahato (50 yrs) S/O- Lt. Lalu Mahato of Vill- Banshradih, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). Two white colour plastic jericans containing approx 16 Ltrs. ID Liquor, 2) Two Plastic Bottle containing 1+1=2 Ltr. ID liquor taken from each of the jariken as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (11.10.2023) during my special mobile duty acting of a secret source information that one person is selling I.D Liquor in his dwelling house at Banshradih village under Tamna PS, Dist-Purulia, so myself along with i) C/1084 Pradyur Ghosh & ii) C/138 Bani Bandhapadhyay both of Tamna PS came to the spot at about 13:15 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Shibaram Mahato (50 yrs) S/O- Lt. Lalu Mahato of Vill- Banshradih, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). Two white colour plastic jericans containing approx 16 Ltrs. of ID Liquor, 2) Two Plastic Bottle containing 1+1=2 Ltr! ID liquor taken from each of the jariken as sample collected from seized articles from Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Shibaram Mahato (50 yrs) S/O- Lt. Lalu Mahato of Vill- Banshradih, P.S- Tamna, Dist- Purulia as per proper section of law.
