Sir.

In producing here with the arrested accused persons namely Sonu Kumar Yadav (25 Yrs), S/O Rajendar Yadav of Vill-Kapasara, Mugma More, PS-Nirsha, Dist-Dhanbad (Driver of the vehicle having Reg. No WB37C/9295 loaded with approx 25 M.T Coal) and seized one vehicle having Reg. No- WB37C/9295 loaded with approx 25 M.T Coal.

The fact of the case in brief is that on 03.11.23 myself along with forces, C/958 Subhas Bauri, C/37 Durjan Murmu all of Adra PS were performing day mobile duty in Adra PS area vide Adra PSCC No 2936/23 dtd.03.11.23 at about 08.15 hrs received a credible source information that the above noted truck loaded with coal was coming from Raghunathpur side towards Kashipur side receiving such information I informed the matter to I/C Adra PS and as per his direction we reached at Adra-Kashipur pitch road near Adra Bus Stand under Adra PS and found that at about 08.35 hrs, one Truck was coming from Raghunathpur side we stopped the said truck and on searching it is found the registration no of the truck is WB37C/9295 and coal was loaded in the truck. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded coal. But the driver of the said vehicle could not able to produce any kind of documents in respect of the truck and the coal. I repeatedly asked the driver and gave him sufficient time to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious him to us. It was ascertained that the driver of the said truck loaded with coal with the owner of the vehicle by illegal means for selling the same to make profit dishonestly and he had been running a clandestine business. As such it is every reason to believe that the driver and owner of the said truck and owner of the said coal were transporting the coal illegally. After finding no other way at about 11.15 hrs I seized the truck having registration No WB37C/9295 loaded with coal under proper seizure list in presence of police party duly signed by them. Thereafter I arrested the accused driver of the above noted truck namely Sonu Kumar Yadav (25 Yrs), S/O Rajendar Yadav of Vill-Kapasara, Mugma More, PS-Nirsha, Dist-Dhanbad, after observing all formalities and narrating him the ground of arrest. The whole process i.e. seizure and arrest was done by 11.15 hrs to 11.45 hrs.

I therefore pray before you kindly lodge FIR against the arrested accd truck driver of the above noted truck namely Sonu Kumar Yadav (25 Yrs), S/O Rajendar Yadav of Vill-Kapasara, Mugma More, PS-Nirsha, Dist-Dhanbad and also owner of the truck Reg. No WB37C/9295 and owner of the seized coal as per law and arrange for its investigation.
