Sir,

In producing here with one arrested accused namely Ranjit Das Modak (53 Yrs) S/O Lt Kista Das Modak of near D.S. Colony Durga Pandal, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 45 bottles (in sealed condition) DIL. KHUSH country spirit, 600-ml each bottle, Rs-50 of each bottle.
- 2) 09 bottles (in sealed condition) DIL. SE country spirit, 600-ml each bottle, Rs-50 of each bottle.
- 3) 04 (Four) bottles CAPTAIN country spirit, 600 ML each Rs/-155 of each bottle

I SI Dipak Kumar Pandey of Adra PS do here by lodged a complaint against accused namely Ranjit Das Modak (53 Yrs) S/O Lt Kista Das Modak of Out House near D.S. Colony Durga Pandal PS-Adra, Dist- Purulia to the effect that on 13/11/23 at about 21-05 hrs I received a telephonic information from a reliable source that one Ranjit Das Modak has been stock of country spirit illegally at his Jhupri at his House near D.S. Colony Durga Pandal. After getting such information I informed to my I/C and as per his direction I along with my accompanied force namely C/2510 Debraj Mal and NVE/969 Praloy Mahato left Adra PS vide Adra PS GDE No-519 dtd 13.11.23. I reached at Out House near D.S. Colony Durga Pandal at about 21.25 hrs and hold raid in the Jhupri of said Ranjit Das Modak and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Ranjit Das Modak has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Ranjit Das Modak selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 21.35 hrs to 22.45 hrs

Hence I there for pray that a specific case may kindly be started against arrested accused Ranjit Das Modak (53 Yrs) S/O Lt. Kista Das Modak of Out House near D.S. Colony Durga Pandal, PS-Adra, Dist- Purulia under proper section of law.
