In producing here with the arrested accused person namely Subha Chakraborty (32 Yrs), S/O Shyamal Chakraborty Vill-Payara Tungi Char, PO+PS-Tamluk, Dist-Purba Medinipur (Driver of the vehicle having Reg. No WB29C/0429 loaded with approx 34 M.T Coal).

The fact of the case in brief is that on 25.11.23 myself along with forces, C/568 Madhusudan Rajowar, C/37 Durjan Murmu both of Adra PS were performing day mobile duty in Adra PS area vide Adra PS CC No 3083/23 dtd.25.11.23 at about 08.25 hrs received a credible source information that the above noted truck loaded with coal was coming from Raghunathpur side towards Kashipur side receiving such information I informed the matter to I/C Adra PS and as per his direction we reached at Adra-Raghunathpur pitch road at Upper Beniasol near 64 Colony under Adra PS and waiting there. At about 08.35 hrs, we noticed that one Truck was coming from Raghunathpur side we stopped the said truck and on searching it is found the registration no of the truck is WB29C/0429 and coal was loaded in the truck. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded coal. But the driver of the said vehicle could not able to produce any kind of documents in respect of the truck and the coal. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious him to us. It was ascertained that the driver of the said truck loaded with coal with the owner of the vehicle by illegal means for selling the same to make profit dishonestly and they had been running a clandestine business. As such it is every reason to believe that the driver, owner of the said truck and owner of the said coal were transporting the coal illegally. As such I arrested the accused driver of the above noted truck namely Subha Chakraborty (32 Yrs), S/O Shyamal Chakraborty Vill-Payara Tungi Char, PO+PS-Tamluk, Dist-Purba Medinipur, after observing all formalities and narrating him the ground of arrest. I also seized the truck having registration No-WB29C/0429 loaded with coal under proper seizure list in presence of police party duly signed by them. The whole process i.e. search, seizure & arrest has done in between 08.45 hrs to 09.35 hrs.

I therefore pray before you kindly lodge FIR against the arrested accd truck driver of the above noted truck namely Subha Chakraborty (32 Yrs), S/O Shyamal Chakraborty Vill-Payara Tungi Char, PO+PS-Tamluk, Dist-Purba Medinipur and also owner of the truck Reg. No WB -29C/0429 and owner of the seized coal as per law and arrange for its investigation.
