Respected Sir,

In producing herewith two arrested persons namely 1) Ujjwal Bauri(34Yrs) S/O Prabodh Bauri Vill-Garchar, PS-Kashipur, Dist-Purulia (2) Parimal Rajowar (18Yrs) S/O Sawpan Rajowar Vill-Gosaidih, PS-Kashipur, Dist-Purulia, along with seized one Blue colour Powertrack tractor bearing Reg. No-WB 82E/2083 along with sand approx 100 Cft loaded Trolley without number plate seized under proper seizure list and memo of arrest in respect of the supra person before you.

The nub of the fact in a nutshell is that today 28.11.2023 while I SI Uttam Kumar Mandal along with force namely 1) C/245 Rabin Rajak 2) NVF/969 Praloy Mahato left the PS for performing evening Petrol duty vide CC No-3112/23 Dated 28.11.2023 and Adra PS GDE No 1125 Dated 28.11.2023 in PS area. During my petrol duty, I received a tip off at 18:35 hrs that a suspicious tractor loaded with sand was coming from Raghunathpur road side towards Adra Town, Purulia. Subsequently, I along with force proceeded towards Beniasol near Adra OP More to work out the tip off. While I along with force arrived at Beniasol near Adra OP More. I asked local people who gathered at that place to become witnesses but none came forwarded and all of them left the place. After that I found that one tractor was coming from Raghunathpur side under Adra PS. I along with force intercepted the vehicle (Tractor) bearing Reg. No- WB 82E/2083 attached with Trolley loaded with sand after placing the guardrail on the road at 18:55 hrs at Beniasol near Adra OP More and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver and workers of the said vehicle disclosed their name noted in the supra. I asked them to produce the valid documents in respect of the vehicle as well as the loaded sand. But they could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked them to produce the valid paper but they stated differently in different times. The incoherent statement of the driver and worker purported to be a suspicious one to us. It was ascertained that the driver of the said tractor along with workers loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Darkeswar River by fraudulently means or theft by any means for transporting the same to run clandestine business. During interrogation the driver and the workers clearly confessed that they habitually deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia Memo No - VI/430 (Part - VII)/1176/M/90/M/17 Dtd.26.06.2020, regarding ban of sand lifting from Riverbed. So I, seized the tractor bearing Reg. No- WB 82E/2083, along with sand loaded Trolley without number plate under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely 1) Ujjwal Bauri(34Yrs) S/O Prabodh Bauri Vill-Garchar, PS-Kashipur, Dist-Purulia (2) Parimal Rajowar (18 Yrs) S/O Sawpan Rajowar Vill-Gosaidih, PS-Kashipur, Dist-Purulia after informing the ground of arrest and issued Memo of Arrest against them. Thereafter, I brought the said tractor to Adra P.S. The whole process i.e. search, seizure & arrest has done in between 19.05 hrs to 19.55 hrs.

Under the above facts and circumstances kindly take lawful action against the driver 1) Ujjwal Bauri(34Yrs) S/O Prabodh Bauri Vill-Garchar, PS-Kashipur, Dist-Purulia and worker (2) Parimal Rajowar (18 Yrs) S/O Sawpan Rajowar Vill-Gosaidih, PS-Kashipur, Dist-Purulia and the owner of the vehicle as they committed offence U/S 188/379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.
