I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC,WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Sraban Gorain, S/O-Hagru Gorain of Village - Gurahata, PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(b) of electricity act 2003 subsequently amendment act 2007.

On 01.11.2023 at about 17:10 o'clock I, along with Alimuddin Ansary,S/O-Lt. Miyazan Ansary, Age-42 years, Senior Technical Support Hand, Arsha CCC, Purulia Division went to routine inspection in Gurahata Village and entered the premises of Sraban Gorain, S/O-Hagru Gorain of Village - Gurahata, PS-Arsha, Dist-Purulia consumer bearing Id-242142463 and found that Sraban Gorain, S/O-Hagru Gorain was enjoying electricity unauthorisedly by bypassing the installed energy meter through a loop connection and enjoying power of WBSEDCL in his premises. The service connection of Sraban Gorain with Meter No. DDB240273 disconnected on the spot from nearby LTOH Line of WBSEDCL on 01.11.2023 at about 17:25 o'clock. During inspection we found the electrical load he is enjoying as 2KW. The inspection team left the premises of the accused person at about 17:35 o'clock.

Sraban Gorain, S/O-Hagru Gorain of Village -Gurahata, PS-Arsha, Dist-Purulia has committed an offence U/S 135 (b) electricity act 2003(Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
