Dear Sir,

I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Sri Nani Gopal Majhi, S/O- Durga Charan Majhi of Village -Kudagara, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(i)(b) of electricity act 2003 subsequently amendment act 2007.

On 09.11.2023 at about 12:05 o'clock I, along with Poulami Karmakar, Divisional Engineer(E), Purulia Regional Office, Bikash Hazra, S/O-Ajit Hazra, AE(Civil), Purulia Regional Office, Sankar Chandra Mahato, Assistant Chargeman, Purulia Regional Office and Alimuddin Ansary, Sr. Technical Support Hand, Arsha CCC. went to routine inspection in Kudagara Village and entered the premises of Sri Nani Gopal Majhi, S/O- Durga Charan Majhi of Village -Kudagara, PS-Arsha, Dist-Purulia consumer bearing Id-202389781 and found that Sri Nani Gopal Majhi, S/O- Durga Charan Majhi was enjoying electricity unauthorisedly by bypassing the installed energy meter through a loop connection and enjoying power of WBSEDCL in his premises. The service connection of Sri Nani Gopal Majhi with Meter No. BB2062202 disconnected on the spot from nearby LTOH Line of WBSEDCL on 09.11.2023 at about 12:25 o'clock. During inspection we found the electrical load he is enjoying as 0.500KW. The inspection team left the premises of the accused person at about 12:30 o'clock.

Sri Nani Gopal Majhi, S/O- Durga Charan Majhi of Village -Kudagara, PS-Arsha, Dist-Purulia has committed an offence U/S 135(i) (b) electricity act 2003 (Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.




