Sir,

In producing here with one arrested accused person Dinesh Gorain (20Yrs) S/O Bhadda Gorain of vill- Kadampur, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) Two white colour plastic containers containing total approx 27 ltrs. of ID liquor.
- 2) One 500 ml bottle approx 500 ml ID liquor taken out from of the above containers as sample packed with sealing wax and labeled)

1. SI Subrata Patra of Arsha PS do hereby lodge a typed complaint against the above noted accused person to the effect that today i.e 11.11.2023 at about 15:35 hrs. during my Spl. mobile duty near Aharrah morh, under Arsha PS area, received source information over telephone that the above noted accused has been selling ID liquor near Kadampur morh under Arsha G.P. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 238 Dipak Bagti of Arsha P.S and C/- 15 Sushanta Kr. Dey of Arsha PS, rushed at Kadampur morh of above noted accused person to work out the information vide Arsha PS GDE No. 419 dtd- 11.11.2023. Reaching near Kadampur morh at about 15:45 hrs. We found that one person was selling of ID Liquor. On seeing police, all customers managed to escape, but we were able to apprehend the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So I seized two white colour plastic containers containing total approx 27 ltrs. of ID liquor under a proper seizure list from his possession in presence of witnesses, properly sealed and labeled it duly signed by the accused person and witnesses out of which approx 500 ml was taken out from the above containers as sample packed with sealing wax and labeled it. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Dinesh Gorain (20Yrs) S/O Bhadda Gorain of vill- Kadampur, P.S.-Arsha Dist-Purulia under proper section of law.
