I, Sukhendu Mudi, S/O-Lt.Mrityunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Arun Kaibarta S/O- Lt-Birbal Kaibarta of Village -Hensla, PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(1)(E) of electricity act 2003 subsequently amendment act 2007.

On 21.11.2023 at about 15.10 o'clock I, along with Abdul Kadir, S/O-Md Salim, Age-28 years, Office Executive, Arsha CCC, and Birendra Nath Gorain S/O- Lt Satish Chandra Gorain Age- 40 years Super Visor Lt Mobile Van Arsha CCC under Purulia Division went to routine inspection in Hensla Village and entered the premises of Arun Kaibarta S/O- Lt-Birbal Kaibarta of Village -Hensla, PS-Arsha,Dist-Purulia consumer bearing Id-200368706 and found that Arun Kaibarta S/O- Lt-Birbal Kaibarta was Supplying electricity unauthorisedly to a deemed disconnection premises of Lalta Kaibarta having consumer ID-202666831 and Out Standing Dues Rs-12095.00 (Rs-Twelve Thousand Ninty Five Only) . The service connection of Arun Kaibarta S/O- Lt-Birbal Kaibarta with Meter No. DDG251948 disconnected on the spot from nearby LTOH Line of WBSEDCL on 21.11.2023 at about 15.15 o'clock..The inspection team left the premises of the accused person at about 15.50 o'clock.

Arun Kaibarta S/O- Lt-Birbal Kaibarta of Village -Hensla, PS-Arsha, Dist-Purulia has committed an offence U/S 135 (1)(E) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
