I, Sukhendu Mudi, S/O-Lt.Mrityunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSedcl, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Karna Mandal S/O- Sibumandal of Village - Arsha, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(1)(E) of electricity act 2003 subsequently amendment act 2007.

On 24.11.2023 at about 15.33 o'clock I, along with Gopal Karmakar S/O- Hari Sadhan Karmakar D.E Purulia RM Office, and Birendra Nath Gorain S/O- Lt Satish Chandra Gorain Age- 40 years Super Visor Lt Mobile Van Arsha CCC under Purulia Division went to routine inspection in Arsha Village and entered the premises of Karna Mandal S/O- Sibumandal of Village -Arsha, PS-Arsha, Dist-Purulia consumer bearing Id-202256049 and found that Karna Mandal S/O- Sibumandal was supplying electricity unauthorisely to a deemed disconnection premises of Sibumandal having consumer ID-242172871 and Out Standing Dues Rs-11826.72 (Rs-Eleven Thousand Eight Hundred Twenty Six and Seventy Two Paisa Only) . The service connection of Karna Mandal S/O- Sibumandal with Meter No. L19549420 disconnected on the spot from nearby LTOH Line of WBSedcl on 24.11.2023 at about 15.55 o'clock..The inspection team left the premises of the accused person at about 16.10 o'clock.

Karna Mandal S/O- Sibumandal of Village -Arsha, PS-Arsha, Dist-Purulia has committed an offence U/S 135 (1)(E) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
