


## Most Respectfully Sheweth:

- 1. That the Complainant and Witness no. 2 Suman Chandra Kumar are two full brothers being the sons of Mihir Chandra Kumar and both are residents of Village- Gobindapur within P.S- Baghmundi.
- 2. That the Accused Persons are also two brothers being the sons of Khagen Kumar and both are residents of Village- Chatatard within P.S- Baghmundi which is 1 KM far from Village- Gobindapur.
- 3. That the Accused Persons represented before the Complainant and his brother that they have got Land at Mouza- Pratapur within P.S- Baghmundi bearing L.R Plot no. 434/952 and they intend to sale the same as they intended to purchase other Plots. The said Accused Persons further disclosed that R.S/L.R Plot no. 434/952 is free from all encumbrances and there is no defect in the title.
- 4. That the Complainant and his brother being swayed away by the emotional words of the Accused Persons agreed to purchase the Plot.
- That initially the Accused Radhagobinda Kumar intended to sale 4 decimals of Property out of R.S/L.R Plot no. 434/952 and accordingly rate was fixed @ Rs. 800000.00.
- 6. That the Accused Radhagobinda Kumar instructed his Deed Writer Hrishikesh Mondal to mention Rs. 400000.00 towards consideration, however the Complainant and his brother paid Rs. 800000.00 to the Accused Radhagobinda Kumar and out of Rs. 800000.00, Rs. 400000.00 was paid through Cash and remaining Rs. 400000.00 was paid through Cheque. The Deed being no. 199 was executed and registered on 03/02/2021.
- 7. That the aforesaid Accused Person said that he will give possession after demarcating the Land. The Complainant and his brother reposed faith upon the Accused Person and they did not question anything to the Accused.
- 8. That the Accused Kripa Sindhu Kumar on 08/09/2021 also executed a Sale Deed in favour of the Complainant and his brother in respect of 2 decimals of Land within R.S/L.R Plot no. 434/952 after accepting Rs. 400000.00 from the Complainant and his brother.
- 9. That the Complainant and his brother purchased the Land measuring 6 decimals vide Two Deeds for the purpose of raising construction. It may be mentioned here that the Complainant and his brother also paid the Stamp Duty and other miscellaneous expenses.
- 10. That the Accused Persons before selling the Land disclosed that the Land which they are going to sale/transfer is free from all encumbrances and there is no defect in the title.
- 11. That in the 2<sup>nd</sup> week of May, 2023, when the Complainant and his brother were ready to construct House over their purchased Land at that time there was resistance from the side of the Irrigation Department though the Complainant and his brother purchased the Property in the year 2021 but due to financial stringencies they could not construct the House.

- 12. That the Employees of Turga Irrigation Scheme objected the Complainant and his brother and on representation the said persons pointed out that the purchased Land of the Complainant and his brother have been acquired by Turga Irrigation Scheme and they have already paid compensation to the Accused Persons. The Complainant and his brother became astonished and the Complainant ultimately sought for Information under the provision of Right to Information Act, 2005, with a copy to District Magistrate, Purulia and on 09/06/2023 the Special Land Acquisition Officer vide Memo no. 699/L.A/R.T.I/V-II/21 sent reply that R.S/L.R Plot no. 434/952 of Mouza-Pratapur have been acquired by L.A Department for Turga Irrigation Scheme and compensation have been given. The Complainant sought for Information on 16/05/2023. The L.A Department also gave a details schedule stating that the Accused Persons Radhagobinda Kumar and Kripa Sindhu Kumar have obtained compensation.
- 13. That the Complainant submits that the Accused Persons have intentionally suppressed rather concealed the said fact before the Complainant and his brother and in this way the Accused Persons have cheated and deceived the Complainant and his brother to the tune of Rs. 1200000.00.
- 14. That the Complainant and his brother have been mentally upset.
- 15. That the Complainant and his brother finally thereafter lodged Complaint on 12/09/2023 before the Officer-In-Charge, Baghmundi Police Station by Registered Post with Acknowledgement Due and the said Notice was served duly.
- 16. That when no action was taken against the Accused Persons by Baghmundi Police and when the Accused Persons are freely roaming then the Complainant and his brother on 18/09/2023 lodged Complaint before the Superintendent of Police, Purulia, with a request to take steps upon the Accused Persons and on 18/09/2023 the said Notice was served upon the Superintendent of Police, Purulia as it appears from Track Consignment Report.
- 17. That the Accused Persons initially obtained compensation from the Government in respect of the self same Property and thereafter by concealing the said fact they have sold the Property again to the Complainant and his brother with a view to fetch more money. So the Accused Persons have intentionally cheated and deceived the Complainant and his brother to the tune of Rs. 1200000.00 and odd and they put financial loss upon the Complainant and they have obtained a wrongful gain.
- 18. That the Complainant is not in a position to file a Case in personal capacity for which the Complainant is filing this Application under Section 156(3) of C.R.P.C.



- 19. That the Accused Persons are still intimidating the Complainant and his brother and they openly gave out that the Complainant and his brother cannot do anything to the Accused Persons as they are Political Leaders and they are financially strong.
- 20. That as Baghmundi Police Station in spite of getting specific information/ complaint from the Complainant has not instituted any F.I.R, so let this complaint be forwarded to O.C Baghmundi Police Station for treating the same as F.I.R and for undertaking investigation.
- 21. That the Photostat copies of the application send to the O.C Baghmundi Police Station, its postal receipt, track report, application submitted before the Superintendent of Police, Purulia are attached herewith this petition with a separate firisti.

Hence it is prayed that Your Honour may graciously be pleased to pass appropriate Orders U/S- 156(3) Cr.P.C by directing the Officer-In-Charge Baghmundi Police Station to treat the complaint as F.I.R and undertake proper investigation.

And

Pass necessary Orders for the Interest of Justice.
