I) and Subhasis Mahato (Sr. O.E.) went to make an inspection to workout upon a source information regarding theft of electricity at the domestic premises of user Janmenjoy Kumar, son of Lt Ashok Kumar, resident of Vill - Nidhiyadi,PO- Uttamdih,PS-Bagmundi, Dist Purulia.

During the time of inspection at the premises 1 no of electricity meter were found having serial no L4481983 (Consumer id 201850165, User Name-Janmenjoy Kumar).

It was observed that accused Janmenjoy Kumar has made unauthorized use of electricity under section 135 1/b & 1/d by inserting foreign material in meter serial no L4481983, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter no L4481983. Prepared seizure list and inspection report. Accused sign to the seizure and inspection documents.
